

### Succession/Estate Planning

Planning for the transfer of assets from one generation to the next must be a matter for consideration for anyone who owns property. Just as variable as the nature and manner of ownership of assets can be between individuals or families, so to can the degree of complexity (and difficulty) be in establishing a successful Succession or Estate Plan. The important thing is that we all need to give the issue of Succession or Estate Planning our due consideration and timely attention. This may involve a simple set of documents (comprising a Will and Power of Attorney) in simple estates to complex and voluminous documents on more complex estates, but will always require good legal, accountancy and taxation advice and may require financial and relationship counselling.

At its simplest Succession/Estate Planning involves a Will. This may be the singularly most important document you will prepare in your lifetime for it is by Will that you have the opportunity of appointing a person or persons to be your legal representative(s) (Executors) and to gift or divest your Estate of your assets after your death.

Consideration should be given to the creation of a Power of Attorney whereby you appoint one or more trusted persons to be your representative(s) during your lifetime to manage your financial affairs and assets (referred to as your inter vivos estate) where you are either physically or mentally incapable (or perhaps both) of doing so yourself.

More complex Estate/Succession Planning may involve dealing with or creating/incorporating trusts and companies and establishing superannuation funds with consequential transfer of assets to those entities. In addition consideration may need to be given to entering into Testamentary Contracts or Deeds of Family Arrangement. A Succession Plan may involve the intergenerational transfer of assets, the execution of a Death Benefit Nomination and always the execution of a current Will.

Added to the documentation that might be prepared in relation to any Succession/Estate Plan will be the professional consideration of actual or potential current or future effects of taxation, stamp duty, and aged care accommodation, entitlements to aged pensions and issues such as family provisions, notional estate, foregone wages contributions and refinancing.

While it may seem daunting to deal with some or all of these issues, to fail to implement a Succession/Estate Plan – whether simple or complex – may simply prove the adage "to fail to plan is to plan a fail".

In considering whether you simply need to update your Will or to embark upon a more complex plan you should seek legal and accounting advice before doing so from your professional advisors.
