

## Android Answers Promotion

### THESE CONDITIONS FORM PART OF THE PROMOTIONAL CONDITIONS FOR THE Android Answers COMPETITION

#### 1. Promotion Summary

The Android Answers competition to commence on Saturday, November 3 and runs until midday, Tuesday, November 13, 2012.

#### 2. CONDITIONS OF ENTRY (“THE RULES”)

a) Information on how to enter and prizes form part of these Conditions of Entry. Entries not completed in accordance with the Conditions of Entry or received after close of entry will not be considered. Incomplete entries will be disregarded. The Promoter’s decision in relation to any aspect of the promotion is final and binding on every person who enters. No correspondence will be entered into.

b) Entry is open to all persons of Australian residence, except for Employees of *The Courier*, Rural Press Printing, Fairfax Media Limited, competition sponsors, their immediate families and associated agencies are ineligible to enter. Entrants under the age of 18 years, must have prior consent to enter from their parent or Legal Guardian.

c) All times are AEST and AEDST during daylight savings periods. The draw will take place at *The Courier* at **Midday on the Tuesday, November 13<sup>th</sup>**. The winners will be determined as per conditions listed here. All winners will be notified in writing and will be published in *The Courier* on the Wednesday, November 14<sup>th</sup>

#### 3. Promotion Entry Details

- a) To enter participants must download The Courier Android App in the Google Play Store. From Saturday, November 3 until Monday, November 13 (10 questions in total) The Courier will publish a daily Android Answers question for readers to answer via The Courier Android App. The winner with 10 correct responses contributed from The Courier’s Android App will be deemed the winner. In the event that more than one person answers all questions correctly the winner will be selected at random from eligible participants.
- b) Entries received after 11:30am on Tuesday, November 13, 2012 will not be valid.
- c) The winner and their companions will be provided with documentation to enable them to make arrangements with the sponsoring organisation to receive their prize.
- d) If the prize or any part of the prize becomes unavailable for reasons beyond the Promoter’s reasonable control, the Promoter will endeavour but is not obliged to provide a substitute prize of equivalent value.

#### 4. Promotion Prize Details
