Dear Joanne,

Thank you for your inquiries.

I acknowledge that AC has chosen to make contact with you and if she wishes to discuss matters with you I respect and support her right to do so. Nevertheless, I fee! constrained to respect the privacy of any person who has been harmed by historic abuse committed by individuals who were part of the Diocese.

On a personal note, I am gladdened if, through my ministry, I have demonstrated respect for and given comfort to any persons harmed by historic abuse.

In the early 2000s I was keen to communicate matters connected with sexual abuse issues to the Australian bishops to create a greater awareness amongst us all of this evil.

The Australian Catholic Bishops Conference (ACBC) continues to have a focus on ensuring the Church responds in the most effective and pastoral way possible to allegations of historic abuse as well as promoting the safety, welfare and well being of all children. The ACBC established the National Committee for Professional Standards, with Directorates in each state. Through the National Committee the Church developed Towards Healing, a comprehensive policy and procedure for dealing with abuse allegations.

As part of the Towards Healing protocols, the Diocese is required to act with truth, humility, healing for the victims, assistance to other persons affected, a just response to those who are accused, an effective response to those who are guilty of abuse and the prevention of abuse.

The Diocese and I have in the past and will continue to cooperate fully with Police investigations. As with any Australian organisation, the Diocese upholds and believes in a person's presumption of innocence in a criminal matter.

In 2005 I established Zimmerman House, a specialist child protection unit that promotes preventative strategies, investigates 'reportable allegations' that are made against any Diocesan personnel and supports the restoration of individuals and groups. Zimmerman House responds to allegations of child abuse by any person associated with the Diocese of Maitland-Newcastle and provides training and information sessions to local parishes, schools and other diocesan groups.
