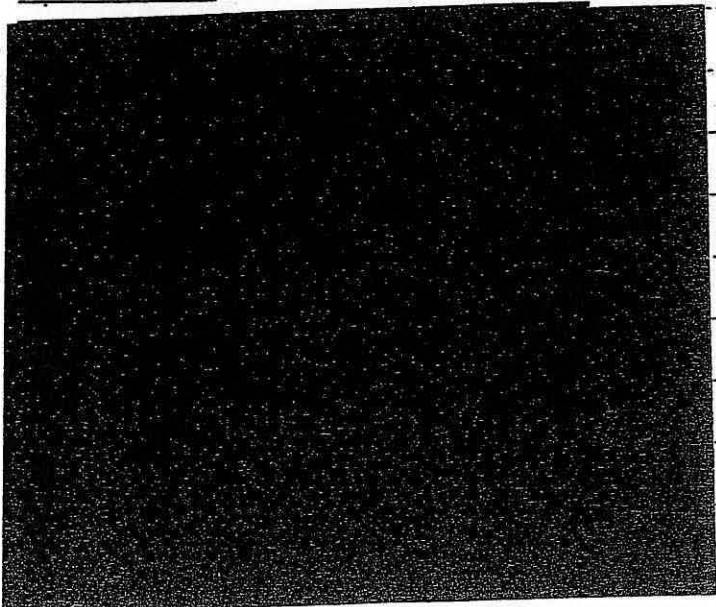


Newcastle LAC – a meeting was held by the North Region Ops Manager and the team investigating the allegations that The Maitland/Newcastle Diocese of the Catholic Church as covered up and suppressed evidence of paedophile priests.

We've dealt with this previously and considered it not a matter for us. However there has been a development in that the investigating police have now a roll over, who was until 2000 the Manager of the Churchs Zimmerman House for problem priests. She had previously apparently been prevented from talking due to confidentiality clauses in her contract. However since being dismissed in 2000 been she has been in contact with a journalist from the Newcastle Herald who has reported widely (locally) on this issue. Real political hot potato with the north region.

I stressed again that it is difficult for the Sex Crimes to investigate the policy, behaviour, methodology of the Catholic Church and their management of allegations of paedophile activity. I did so both with the Acting Region Ops manager and the OIC. They were scheduled to commence taking the statement from the roll over on Monday so I arranged for Nigel and one other to go up, debrief the OIC and assess the type of product coming from the roll over, this interview has now been deferred until Friday. Propose to sent two up Thursday, go through the brief with the OIC during the afternoon and be present to assess the product coming from roll over on Friday.
