He informed that a person apparently from the Newcastle area had contacted the National Office (and who had subsequently contacted Peter) threatening to go to the press about Father McAlinden at some point allegedly ministering in the Diocese of Banbury.

Bishop Malone's information that McAlinden had been stripped of his facilities and retired from active ministry in 1993.
Bishop Malone had personally liaised with Bishops in WA and the Philippines to warn them off using McAlinden.

Also informed Peter that the relevant people within the Maitland-Newcastle Diocese and with whom he should liaise are:-

1. The Vicar-General Father Jim Saunders (in the absence of the Bishop who is on leave)

3. Ms Helen Keevers of the Diocesan Child Protection office.

Suggested that he might start with Helen Keevers to give him the relevant contact details.
