Brief Narrative: When I was about 4 and a resident of Blackville Fr Mack took me and y older sister to Murrurundi for the weekend. He was a friend of my mother who came to dinner more than once when relieving in the area. On the weekend concerned he had come to supper, left afterwards with me and my sister. I did not really know where I was going until we got there. There did not seem to be power in the house, it was dark and he used candles. Once he had put us into bed with him he left one candle lit. I fell asleep almost straight away. I was woken up by him taking my pants off. He said I had weed them, or soiled them and that was why he took them off. He got tissues or toilet paper or something similar and started wiping, then he removed whatever he was using and started to use his fingers. I went to sleep and when I woke again he was rubbing his penis against me... At some point he put his penis in me and I began to cry and say 'It's hurting'. I don't remember much more of what happened but we went to church the next day. There was blood on the bottom of my nightie but it did not come home, nor did my knickers or shorts.
