I have a document written by the late Bishop Leo Clarke to McAlinden on October 19, 1995, informing McAlinden the diocese had begun an impediment to the exercise of orders case, which says the decision was made "In the light of your admission to Fr Brian Lucas and other evidence".

Is there another Fr Brian Lucas?

I also have a letter from McAlinden to Clarke dated October 26, 1995, in which he says "Incidentally, the word 'confidential' has a very hollow ring as far as Maitland is concerned: Brian Lucas convinced me, against my better judgement, to accept that the information I gave him would be held in strict confidence by the bishop".

If there is another Fr Brian Lucas I need to put these questions to him.

Can you confirm you had contact with McAlinden?


Can you confirm information was conveyed by you to the then Maitland Newcastle Bishop Leo Clarke after a conversation or session with McAlinden?
