 During the period of time 1990 – 2000 the MCCF made payments electronically, by cheque and by International Money Transfers (IMT's) (for some overseas priests) on a monthly and quarterly basis. Those receiving funds under the Sick

& Retired Clergy scheme were paid quarterly.

e) 1998 Spreadsneet showing last payment made in 1997.

- f) The list of priest addresses held within the records of the MCCF was updated on a regular basis and previous persons were not maintained on that list. The Diocesan Chancery would be the only other place were a full list of addresses is maintained.
- 4) I am not aware of any money in the form of "Clergy Advances" being made from the MCCF to Fr D McAlinden.



The Diocese, through the office of the Financial Secretariat processed those transactions. In 2000 on the death of Mgr Coolahan, I, Mgr Allan Hart, was elected as Secretary of the MCCF, and started to transition the MCCF and established our own office.






