ANNEXURE TO SUMMONS TO PRODUCE DOCUMENTS
Summons No. 2(c)

1. Any documents comprising chapters or sections, whether draft or otherwise, of any book being prepared by Detective Chief Inspector Peter Fox in so far as such chapters or sections refer to relate to:
 - (a) any Investigations undertaken by DCI Fox or any other person in respect of alleged sexual abuse committed by Fr Denis McAlinden ("McAlinden") and/or Fr James Fletcher ("Fletcher"), and/or of any alleged concealment of such offences by any person;
 - (b) any hindering, obstructing of any Police investigation relating to McAlinden or Fletcher;
 - (c) the circumstances in which DCI Fox was asked to cease investigating any matters relating to McAlinden and/or Fletcher, including any alleged concealment by any person of offences committed by McAlinden and/or Fletcher;
 - (d) any matter that has been the subject of evidence before the Special Commission of Inquiry; and/or
 - (e) any evidence given by DCI Fox or any other person before the Special Commission of Inquiry.

In this Summons:

"document" means any record of information and, without limitation, includes emails and SMS messages.
