On my return from annual holidays this week I found awaiting me a letter from one of my priests, Fr D McAlinden, dated 13th September.

In this letter Fr Mc Alinden has asked my approval of one of two options suggested by yourself (his words):

My Lord,

I wrote to you on 8th November, 1994 when I received a letter from a priest of this Diocese, Fr Denis McAlinden, requesting permission to work in your Diocese. I enclose a copy in case you did not receive it.

I now wish to explore the reasons why I could not give this permission.

In 1994 serious allegations were made against Fr Denis. In being confronted by these accusations by a priest deputed by the Australian Episcopal Conference, Fr Denis admitted to the accusations. The agreement entered into was that Fr Denis should retire to Ireland. This agreement found endorsement from those who had filed the accusations.

Some people of my Diocese have now learnt that he is not in Ireland but is supposedly working in your Diocese. They have demanded to know whether this is true.

Could you please advise me that if he has been working in your Diocese that you will now withdraw his faculties and that you will advise him to return to Ireland.

I fear that if this is not done then the people concerned could well proceed to the next step. This would have serious implications to both your Diocese, this Diocese and to Fr Denis and the Church.

Thanking you for your cooperation in this difficult matter.


Concerning the present situation of Fr. McAlinden, I was told by the Rector of San Pablo Cathedral, Fr. Mar Castillo, that Fr. Denis left the Philippines last August 3 for Australia. We do not know the exact address of his residence, although information can be sought from New Wales, Australia, concerning his whereabouts in that country. Fr. Denis McAlinden no longer has any connection with the San Pablo diocese, and all his faculties have been revoked. It is unfortunate that there was no swift communication between the Dioceses of Maitland and San Pablo in order to have avoided this uncomfortable situation. However, Your Excellency may be assured that such cases would no longer be accepted and repeated in our diocese, and would be duly avoided by conducting the most detailed inquiry concerning any guest priest that may decide to help in the diocese.

Dear Bishop Famadico

Special Commission of Inquiry into matters relating to the Police investigation of certain child sexual abuse allegations in the Catholic Diocese of Maitland-Newcastle ("Inquiry")

I refer to the above Inquiry and to the telephone conversation between Catherine Vale, of my Office, and Father David Reyes, on 21 March 2013.

As explained by Ms Vale, pursuant to letters patent dated 21 November 2012 and 25 January 2013, issued by the Governor of New South Wales in accordance with the *Special Commissions of Inquiry Act 1983 (NSW)* (copy **attached**), Ms Margaret Cunneen SC has been appointed as Special Commissioner to inquire into and report on the investigation of certain child sexual abuse allegations in the Catholic Diocese of Maitland-Newcastle, specifically in relation to allegations of sexual abuse against Father Denis McAlinden.

I assist the Commissioner in relation to the Inquiry.

Inquiry's terms of reference

Pursuant to the Letters Patent, the Terms of Reference for the Inquiry require that the Commissioner inquire into and report on:

- 1. the circumstances in which Detective Chief Inspector Peter Fox was asked to cease investigating relevant matters and whether it was appropriate to do so; and
- 2. whether, and the extent to which, officials of the Catholic Church facilitated, assisted, or co-operated with, Police investigations of relevant matters, including whether any investigation has been hindered or obstructed by, amongst other things, the failure to report alleged criminal offences, the discouraging of witnesses to come forward, the alerting of alleged offenders to possible police actions, or the destruction of evidence,

A copy of the Inquiry's Terms of Reference are attached for your reference.

Request for documents relating to Father Denis McAlinden

As you may be aware, Father Denis McAlinden spent some time in San Pablo Diocese from 1994 to 1995. Specifically, I understand that:

 from about September 1994 to August 1995, Father McAlinden lived in the Chaplain's Residence in San Pablo City and was actively involved in work in the San Pablo Diocese.

During the whole of this period, Father McAlinden remained incardinated to the Maitland-Newcastle Diocese. Father McAlinden died in Western Australia in November 2005.

As part of its investigations, the Inquiry desires to obtain copies of certain documents that may be held by the San Pablo Diocese relating to Father McAlinden. In effect, the documents sought are:

- (i) the 'Bishop's file' relating to Father McAlinden (or comparable file, howsoever named, containing records of complaints, misdemeanours, etc relating to Father McAlinden);
- (ii) documents regarding any complaints, reports or recorded suspicions of child sexual abuse by Father McAlinden; and
- (iii) documents recording communications between the respective Diocese (San Pablo) with Police (Philippines or New South Wales), and/or the Maitland-Newcastle Diocese regarding Father McAlinden, including any documents referring or relating to any complaints, reports or recorded suspicions of child sexual abuse by Father McAlinden.

The Commissioner would be most assisted if you could undertake a review of documents held by the San Pablo Diocese (including in the diocesan archives) to ascertain whether any such documents are held, and if so, to provide copies of the same.

As the Inquiry will be holding public hearings in May and June 2013, your expedition in this matter would be much appreciated.
