

Statement of Graeme John Parker

Special Commission of Inquiry into matters relating to the Police investigation of certain child sexual abuse allegations in the Catholic Diocese of Maitland-Newcastle

Preliminary matters

1. This statement is prepared by me for the sole purpose of responding to a summons dated 12 February 2013 issued on 13 February 2013 by the Special Commission of Inquiry (established by way of letters patent dated 21 November 2012 and varied by letters patent dated 11 January 2013) for me to produce a statement in relation to a number of defined issues. This statement is produced by me to the Special Commission of Inquiry pursuant to the said issued summons unwillingly and only on the basis that, without exception, section 23(2) of the Special Commissions of Inquiry Act 1983 applies to restrict the use of this statement and the documents referred in it, and attached to it. Pursuant to section 23(2) of the Special Commissions of Inquiry Act 1983 I object to the information contained within this statement, and the attachments to the statement, being used in any criminal, civil or other proceedings or inquiries or investigations of any kind.
2. My full name is Graeme John Parker and I am a Detective Inspector with the New South Wales Police Force (NSWPF) attached to the Newcastle City Local Area Command.

Background

3. I was attested as a police officer in December of 1987. After the date of my attestation I served 5 years in general duties at Kurri Kurri. I was then transferred to the Special Operations Group located at Maitland where I served for a period of 2 years from 1992 to 1994. The major part of the Special Operations Group's work related to the investigation and prosecution of drug related offences.
4. Thereafter, and from 1994 onwards, I carried out plain clothes duties at Raymond Terrace. In this role I was involved in investigating and prosecuting a range of criminal activity, including child sex abuse matters. In 1995 I completed the Initial Response Officer Course which qualified me to interview and obtain statements from child and adult victims of sexual assault.
5. Also during this period I was one of two investigators conducting inquiries on behalf of the New South Wales State Coroner into the Seaview Air Disaster. On the recommendation of State Coroner Derrick Hand I was formally recognised departmentally for this investigation.
6. In 1996 I was engaged in the Detective Education Program. During the course of the same year I was designated as a Detective. Also, I undertook a Bachelor of Policing (Investigation) course at the Charles Sturt University, which I successfully completed in 1998.
7. In the years 1997 and 1998 I was attached to Strike Force Matre. This Strike Force was engaged in the investigation of outlaw motorcycle gangs. After my

secondment to Strike Force Matre came to an end, I returned to my previous position at Raymond Terrace and subsequently, Lower Hunter Detectives up until 2000.

8. During this period I was selected by the Crime Manager at Lower Hunter Local Area Command to undertake a controlled operation into drug distribution in the Cessnock area. I was again formally recognised departmentally for this investigation.
9. In 2000 I was attached to Strike Force Sibret, which was a joint crime command Northern Region operation. The work of the Strike Force also related to outlaw motor cycle gangs and was subjected to the highest possible security levels. The Commissioner formally recognised both the Strike Force, as a unit, and me, as an individual, for this investigation.
10. In 2002 I was promoted to the rank of Detective Sergeant within the NSWPF. I was stationed at the Singleton Police Station which is part of the Hunter Valley Local Area Command. My primary work was general criminal investigations. I was responsible for the day to day management of all investigations and staff attached to the Singleton Detectives Office. During this period I was Investigation Supervisor of Strike Force Kyema, a joint Homicide and Hunter Valley LAC operation. I was again formally departmentally recognised for this investigation.
11. In 2006 I was promoted to the rank of Inspector in the Hunter Valley Local Area Command. In 2008 I was transferred to the Crime Manager's position at Brisbane Waters Local Area Command with the substantive rank of Detective Inspector. In March of 2011 I transferred to Newcastle City Local Area Command as Crime Manager with the substantive rank of Detective Inspector.

2 December 2010 meeting

12. I was present at a meeting which occurred on 2 December 2010 at the Waratah Police Station relating to Strike Force Lantle. In 2010 I was still attached to the Brisbane Waters Local Area Command, and my involvement in attending the meeting on the 2nd of December was in the capacity of relieving Inspector Townsend in his position Operations Manager for Northern Region. To the best of my recollection, I commenced the relieving duties for Inspector Townsend on 21 October 2010 because of Inspector Townsend being taken 'off line' to manage a Northern Region Operation in the Hunter Valley Local Area Command. **Annexed to this statement and marked "A"** is a copy of the minutes of the meeting on 2 December 2010.
13. After finishing those relieving duties I returned to the Brisbane Waters Local Area Command for a period of time until I was later transferred to the Newcastle City Local Area Command in March of 2011.
14. Prior to my attendance at the meeting on 2 December 2010, I had little knowledge in relation to Strike Force Lantle, other than some media reports regarding the Strike Force. Before the 2 December meeting I received a short briefing about issues surrounding the Strike Force. My recollection is that I was briefed on this matter by Assistant Commissioner York and Inspector Townsend. They gave me a general briefing and provided me with some basic information in relation to the meeting and Strike Force Lantle. Part of that briefing was that I was to ensure that the Region's position was adhered to. I was made aware that Newcastle Local Area Command was reluctant to take carriage of the investigation, as their position was that the State Crime Command should be responsible for the investigation.

Region's position was contrary to this, and I was tasked to ensure that Newcastle accepted responsibility for the carriage of Strike Force Lantle.

15. It was also a concern to Region that there appeared to be someone within the NSWPF leaking information to the Newcastle Herald about the investigations undertaken by Strike Force Lantle. My role, within the meeting, was to ensure Region's position was to be made clear to all present. That position was that the Newcastle City Local Area Command was to be responsible for the investigation and that any future unauthorised media statements were to cease immediately.
16. I have read the investigator's note relating to the meeting of the 2 December 2010. To the best of my recollection, what is recorded and contained in the meeting note accords with what occurred during the meeting. As the notes themselves record, I came to the meeting a short time after it had commenced, with my delay being a result of other necessary commitments which I had to attend to at the time.
17. At the time of the meeting on 2 December 2010 I was aware that Strike Force Lantle had already been set up. Further, I was aware that Detective Sergeant Steel was the officer in charge of the Strike Force and in that capacity she was responsible for running the Strike Force.
18. In terms of the change of investigator from Detective Sergeant Steel to Detective Sergeant Little, it was my understanding that the reason why Detective Sergeant Little was appointed as the officer in charge was because Detective Sergeant Steel went on medical leave towards the end of December of 2010.
19. After the meeting of 2 December 2010 was concluded, I made an entry in my personal diary relating to what occurred at the meeting. Annexed to this statement and marked with the letter "B" is a true copy of the diary entry which was made by me at the time. The diary entry records the following:-

Meeting with Mitchell, Tayler, Quinn, Steel, Haggett and Fox re Catholic Church investigation. Mitchell issues direction that all officers involved in the investigation and management issue are not to speak with the press on issues without authorisation from himself. Further enforced when I explained region's position on this issue. It was clear that NMH has pipe line to investigation which needs to be stopped as it is effectively hampering the progress of same. Everyone states they understand. Discussion is Newcastle will have carriage of matter. Fox to pass on all knowledge and statements etc to Steel in handover.

20. After completing my relieving as Northern Region Operations Manager, I returned to my substantive duties at the Brisbane Waters Local Area Command. I had no further involvement with Strike Force Lantle until March 2011.

March 2011 and the resourcing of Strike Force Lantle

21. In March 2011 I transferred to the Newcastle City Local Area Command as Crime Manager. By virtue of my substantive role, I assumed overall responsibility for Strike Force Lantle from Detective Chief Inspector Tayler who had left the Local Area Command. As part of my duties and functions in my current role within the Newcastle City Local Area Command, I have the responsibility of managerial oversight of all serious investigations, ensuring they are staffed and resourced adequately and appropriately, and generally ensuring investigations progress in a timely and appropriate manner.

22. Shortly after commencing my role of managing and overseeing Strike Force Lantle I received a briefing from the Officer in Charge of the investigation, Detective Sergeant Little. I also reviewed the Strike Force holdings and familiarised myself with the direction and charter of the investigation. I was completely satisfied with the manner in which the Strike Force was being conducted by Detective Sergeant Little. It was my belief that appropriate personnel were attached to the Strike Force, and I also have the view that the investigation was carried out in a highly professional manner, particularly given the difficulties that the investigators faced.
23. During the investigation a number of managerial decisions were made. One of these decisions was to minimise the number of police officers attached to the Strike Force to ensure the integrity of the investigation was not further compromised. By limiting the number of officers involved, it was felt greater control could be exercised over the integrity of the investigation. It was my understanding that one of the reasons Detective Sergeant Little was chosen to be the officer in charge of the investigation was because of his integrity and thoroughness as a police officer.

Detective Chief Inspector Fox's involvement in Strike Force Lantle

24. In terms of whether Detective Chief Inspector Fox was an appropriate person to play an active role in Strike Force Lantle, it was my view that it would not have been appropriate for him to play any active role in the investigation for the following reasons.
25. The Region Commander determined that Newcastle LAC was the command best placed to undertake and manage the investigation. Strike Force Lantle was established by that command.
26. At the commencement of the Strike Force, up until the present time, Detective Chief Inspector Fox was and remains attached to the Port Stephens Local Area Command as a Crime Manager. It would be most unusual for a person in that position, whoever it may have been, to be given a management role, with respect to a Strike Force, in a different local area command.
27. Once carriage of the Strike Force had been allocated to Newcastle LAC, Detective Chief Inspector Fox's role with the Strike Force would necessarily be limited. Based on my experience, it would have been unprecedented for a person in Detective Chief Inspector Fox's rank and position to have been given any active, primary role as an investigator for Strike Force Lantle. Once this was determined, the management of the Strike Force proceeded in accordance with the standard operating procedures of the NSWPF.
28. If Detective Chief Inspector Fox had been brought in to play a direct role in Strike Force Lantle, it would not have been in the capacity of an investigator, but into a role that more befits his rank and position within the NSWPF. That level would have been Crime Manager and Supervisor of the Strike Force. This role had already been assigned to Detective Chief Inspector Tayler and subsequently to me. As stated earlier, this was determined by the original allocation of the Strike Force to Newcastle LAC by the Region Commander and positions were assigned by standard operating procedures in accordance with NSWPF protocols. Any divergence from this would have been highly irregular.
29. To the best of my recollection, at the time I attended the meeting of 2 December 2010, and after I took over my duties at the Newcastle Local Area Command in March of 2011, I had no knowledge of Detective Chief Inspector Fox being involved

in any active investigation which related to any matter relevant to Strike Force Lantle.

30. After I began managing the investigation from March of 2011 I had direct dealings, in my capacity as a Crime Manager, with Detective Sergeant Little. Detective Sergeant Little was responsible for the day to day running and management of the investigation, however, we did consult on a regular basis with respect to the progress of the investigation, the future direction and investigation avenues, and associated matters. Detective Sergeant Little conducted a number of interviews with various corroborating officers. However, to ensure the integrity of the investigation, it was mutually agreed that only Detective Sergeant Little and I would conduct interviews that were determined to be of a sensitive or discreet nature or that presented a risk to the probity of the investigation.
31. As a result of the meeting on 2 December 2010, I was of the belief that Detective Chief Inspector Fox had produced copies of all relevant information he had in his possession to Strike Force Lantle. This opinion did not change after I took over as Crime Manager in March 2011. I was, however, aware that Detective Chief Inspector Fox had forgotten to bring copies of his original documents to the initial meeting that occurred on 2 December 2010.
32. After several discussions with Detective Sergeant Little about this matter, and in the interest of completeness and thoroughness of investigations, it was decided a final formal approach should be made to establish if Detective Chief Inspector Fox held any other information significant to Strike Force Lantle. This occurred in April 2012.

Communication with Detective Chief Inspector Fox on 30 March 2012

33. At about 15.57 on 26 March 2012 Detective Chief Inspector Fox forwarded an email to Superintendent Gralton and others with the subject heading being "NP Trail". Annexed to this statement and marked with the letter "C" is a copy of the said email. To the best of my recollection, I was consulted by Superintendent Gralton in relation to the matters raised by Detective Chief Inspector Fox in the body of the email, so as to give some input into how Superintendent Gralton should respond. Annexed to this statement and marked with the letter "D" is a copy of an email forwarded by Commander Gralton of the Newcastle City Local Area Command to Detective Chief Inspector Fox in response. The email was sent at 15.36 on 30 March 2012.
34. In terms of the indication given by Commander Gralton to Detective Chief Inspector Fox relating to the directions given to him by Superintendent Mitchell and as to whether they were still in force, to the best of my recollection, my input was that if any such directions had been given by Superintendent Mitchell it should remain in force as long as the Strike Force remained in operation. I was in agreement with such a response being given to Detective Chief Inspector Fox, particularly as it was my view that the integrity of the investigation by Strike Force Lantle should not be compromised with respect to any leaking of information to any person associated with the media.

Communication with Detective Chief Inspector Fox on 2 April 2012

35. On 2 April 2012 I made arrangements to meet with Detective Chief Inspector Fox for the purpose of obtaining any further information that may have been in his possession in relation to the investigation. Arrangements were made for a handover of any information to take place on the 3rd of April. Because of unforeseen

circumstances, Detective Sergeant Little and I were unable to keep this appointment. On 4th April 2012 Detective Sergeant Little and I were returning to Newcastle from Sydney. I contacted Detective Chief Inspector Fox by the hands free car phone and the call was monitored over the car loudspeaker. At the commencement of the conversation I made Detective Chief Inspector Fox aware of that fact, and indeed, Detective Sergeant Little introduced himself via the hands free system.

36. Annexed to this statement and marked with the letter "E" is a copy of a file note which was created by Detective Sergeant Jeffrey Little. To the best of my recollection, the contents of the file note correctly record the terms of the conversation had with Detective Chief Inspector Fox.
37. Annexed to this statement and marked with the letter "F" is an email forwarded by Detective Sergeant Little to Detective Chief Inspector Fox (with a copy being forwarded to me on the email). The email is timed and dated as 13.05 on the 2nd of April 2012. The annexure also contains an email forwarded to me by Detective Chief Inspector Fox at 12.25 on 2 April 2012.
38. Apart from the matters dealing with the direction given to Detective Chief Inspector Fox referred to in this statement, I was not involved, to the best of my recollection, with any other occasion when any direction, instruction or communication was given to Detective Chief Inspector Fox with respect to the handing over of files or with respect to his speaking with the media.

Report of 19 November 2012

39. In November 2012, Assistant Commissioner York requested that I prepare a report in relation to Strike Force Lantle. Annexed to this statement and marked with the letter "G" is a copy of that report.
40. On 22 August 2012, Strike Force Lantle investigation was completed when a brief of evidence consisting of 2970 pages with a summary of 255 pages prepared by Detective Sergeant Little was given to the NSWPF Legal Services Unit. Subsequently, this brief and summary was served on the Office of the DPP for their assessment as to whether any charges would be preferred against any person. The Office of the DPP is still considering the matter.

Conclusion

46. As far as I am concerned, and based on my experience as a police officer with 26 years of service with NSWPF, the instructions given to the police officers in attendance at the meeting of the 2nd of December 2010 were both proper and appropriate, as was the response by Commander Gralton in his email forwarded to Detective Chief Inspector Fox on 30 March 2012.

Detective Inspector PARKER (Northern Region) arrived midway through the meeting.

Superintendent MITCHELL outlined that Newcastle City LAC has carriage of investigations relating to *AK, AL* and *GOGERTY*. This was at the direction of the Region Commander. Mr MITCHELL identified that the investigations presented a high level of risk to the organization and needed to be managed well. He acknowledged that Detective Inspector FOX had a strong background in relation to the nature of the complaints, and that for the investigation team to perform their function, it was essential that he disclose all relevant information to the team.

Inspector FOX indicated that he had compiled all relevant documents held by him, but had mistakenly left them behind. He indicated that he had no problem disclosing information held by him to the investigation team. He indicated that he would make arrangements for the documents to be presented to the investigation team. He indicated that the information available would indicate that the clergy abuse/cover up is widespread and that there is a need for a broad ranging task force to be established to investigate it. He indicated that he had recently documented this in a report to the Region Commander.

In order to control confidentiality in relation to the investigation, Supt. MITCHELL indicated that nobody was to speak to the media (including Joanne MCCARTHY) without his knowledge. Mr MITCHELL indicated that in the event police are contacted by MCCARTHY, he was to be advised.

Inspector FOX indicated that in addition to his knowledge of the AK and AL cases, he had interviewed another lady named AJ. FOX indicated that AJ had only wanted to deal with him. She is a victim and a witness and has information dating back to the 1980s about offending behaviour by high ranking members of the Catholic Church including REDACTED HART, CLARKE and LUCAS. He indicated that she was from an inner sanctum of the Church and had been privy to a lot of conversations. She is born in 1951 and was ten when offences occurred against her. He indicated that she was very fragile.

Inspector FOX also indicated he had a statement from a Mike STILLWELL who was a teacher at Merriwa.

Inspector FOX indicated that he had begun obtaining a statement from AK who resides in Queensland. He indicated that a loose arrangement had been made to complete that statement when AK turned to the Newcastle area over the Christmas break.

Inspector FOX indicated that he had interviewed Leo CLARKE after his retirement, primarily in relation to his investigations concerning FLETCHER and RYAN. He did however speak with CLARKE about MCALINDEN. He believes that CLARKE deliberately lied to him when CLARKE advised him that he knew of no other incidents involving MCALINDEN.

Inspector FOX indicated that he had come into the investigations on and off over the years. He indicated that in 2004 he submitted two reports to SCC calling for a far reaching investigation of the incident. He had also submitted a number of information reports. He indicated that he had informants in the form of a former priest and sister. He indicated that he had no doubts that there was collusion in the Church.

Det. Insp. PARKER arrived at this stage of the meeting.

Insp. FOX indicated that due to the scale of the investigation it was imperative that a task force was established.

Supt. MITCHEL indicated that there was a need for LAC Investigators to collate available information at this stage in order to allow further assessments to be made.

Insp. PARKER indicated that the Region Commander's firm view that the file was to remain with the LAC. It was a matter for the LAC to collate the information and present that to S.C.C. If that was appropriate. Insp. PARKER indicated that if the information gathered went beyond the Terms of Reference, the L.A.C. would need to identify why.

Insp. FOX outlined that the information given by AJ discloses other witnesses and potential witnesses. He reiterated his earlier view that a task force needs to be pursued.

The meeting was concluded at this point and Supt. HAGGETT and Insp. FOX departed.

Inspector TOWNSEND arrived at this time and was briefed by Sgt STEEL. Present for this briefing were:

- Supt. MITCHELL
- DCI TAYLER
- Insp. PARKER
- Insp. TOWNSEND
- Det. Sgt. STEEL
- Det. Sen. Const. FRENEY
- Det. Sen. Sgt. QUINN

Det. Sgt. STEEL indicated that she had spoken with Helen KEEVERS earlier that morning. KEEVERS was the Manager of Zimmerman House for 30 years. She indicated that she had a high level of knowledge about MCALINDEN'S offending and other priests and victims. She indicated that she has seen numerous critical documents outlining such conduct.

She indicated that the most crucial documentation had been forwarded by Zimmerman House to the Catholic Church's Insurance body. She made reference to a document authored by Monsignor COTTER where he indicated that it was fortunate that MCALINDEN'S offending was on children and not adults and females. She also indicated that MCALINDEN had engaged in a course of conduct regularly used by Catholic Priests where children were taken swimming in deep water so that they would need to hold onto the priest for assistance.

STEEL outlined the 'Encompass' program that was set up by Archbishop PELL to treat priests who have problems (primarily child abuse). The program maintained files outlining the problem behaviours and identified treatment plans. KEEVERS indicated that PELL had closed the program down without notice. She indicated that the files relating to the program had been moved by a man known to her for storage.

STEEL indicated that senior clergy moved MCALINDEN to P.N.G. for a period after his offending behaviour was discovered.

Other Senior Clergy (BURSTON/HART and LUCAS) were involved in cover ups.

KEEVERS told STEEL that police would only get one chance at a search warrant because she is certain that Church members would destroy documents.

Supt. MITCHELL indicated that the issue for the L.A.C. is the scope of the investigation. Inspector TOWNSEND agreed that the scope of the investigation had greatly broadened since it was first allocated to the L.A.C. It was agreed that the following would occur:

1. Inspector PARKER would contact Insp. JACOBS of S.C.C. to invite an investigator(s) from Sex Crimes to attend a debrief to be held with KEEVERS.
2. Det. Sgt. STEEL to conduct the debrief in the week commencing 6 December 2010.
3. Det. Sgt. STEEL to collate all information available to date after the debrief and formulate a summary document to be forwarded to S.C.C. for their consideration as to whether or not the investigation would fit their charter.

In 2010 I made submissions to investigate paedophile activity by the Catholic Church following past prosecutions & approaches to me by victims through a newspaper reporter Joanne McCARTHER. I obtained statements before being aware of inquiries at Newcastle. I contacted Investigators there & was then directed by Superintendent MITCHELL to surrender all the documentation I had, including victim statements, cease any involvement in church paedophilia investigations or dealings with victims. I was also directed to not contact Joanne McCARTHY & report any contact with her immediately. I was further directed to hand over a separate non-related ministerial file sent to me as a

result of my past investigations into paedophilia in the Catholic Church.

Complying with my directions I am reporting I was contacted today by Det Sgt Kristy FABER requesting I assist in connection with the trial of **NP** which is currently underway. I was asked if I could obtain a photograph of Fr James FLETCHER from about 1980. I was also asked to ascertain the whereabouts of Fr FLETCHER & **NP** around that time & if they had access to Campbell's Hill Church at Maitland or any association between them.

I spoke to persons (But not Joanne McCARTHER) in confidence who are assisting. I may have further contact to secure photographs & other information. ISSUE:

Request for information by Assistant Commissioner York regarding delays associated with the investigations conducted by Strike Force Lantle, including investigation contacts with Detective Chief Inspector Peter Fox of Port Stephens Command.

BACKGROUND:

On 12 July 2010 Operations Manager, Northern Region, Inspector Anthony Townsend produced a eleven page document addressing allegations of the concealing of serious offences by former and current clergy attached to the Newcastle Maitland Diocese of the Catholic Church. This appears to have been as a result of information, including statements, received by Lake Macquarie LAC from Journalist Joanne McCarthy. The file was furnished to the Region Commander, Northern, who signed off on her instruction to the Commander Newcastle City LAC on 1 September 2010. Those instructions included the identification of suitable investigators, initial assessment of evidence, the utilisation of State Crime Command in an advisory capacity with a view to handing over the investigation at a later stage, if deemed appropriate. Should the matter fall outside the charter of the State Crime Command, Newcastle LAC would retain investigative carriage of the matter.

In early October 2010 Strike Force Lantle commenced investigations into allegations of sexual misconduct by clergy from the Newcastle/Maitland diocese of the Catholic Church. The Strike Force consisted of Detective Senior Sergeant Justine Quinn, Detective Sergeant Kirren Steel and Detective Senior Constable Jason Freeney and was under the hegemony of Detective Chief Inspector Bradley Taylor, the then Crime Manager of Newcastle City LAC. At that time an E@glei investigation was also commenced.

It is clear from records within the E@glei holdings that difficulties between Investigators/Managers of Lantle and Detective Chief Inspector Fox seem to have commenced almost from the beginning of the investigation. This would appear to relate to issues concerning investigative responsibility for the complaint and the possession of files/statements pertaining to Lantle. There is also an underlying issue regarding the probity of the investigation, particularly to what appears to be a constant leaking of information to Ms McCarthy.

On 2 December 2010 a meeting was held between officers from Newcastle City LAC, Port Stephens LAC and Northern Region to resolve issues surrounding Strike Force Lantle. Superintendent Mitchell commenced the conference by explaining that Newcastle City LAC had carriage of the

Investigation at the express direction of the Region Commander, Assistant Commissioner York. As such he required DCI Fox to hand over all documents pertaining to S/F Lantle. DCI Fox indicated that he was happy to comply, but had mistakenly left the documents in question back at the Raymond Terrace Police Station. DCI Fox also mentioned a report he had recently supplied to the Region Commander.

Superintendent Mitchell directed that no officer was to speak to the media, including Joanne McCarthy without his knowledge. He added that any contact by Ms McCarthy needed be reported to him.

On 13 December 2010 Detective Sergeant Steel reported off on sick report and did not return to duty.

On 20 December 2010 Detective Chief Inspector Taylor reported off on sick report and did not return to duty.

On 21 December 2010 Detective Senior Sergeant Quinn reported off on sick report. He returned to Duty on 21 February 2011 only to again report sick on 4 April 2011. He did not return to duty.

On 30 December 2010 Detective Sergeant Jeffery Little was seconded to Strike Force Lantle to replace Detective Sergeant Steel.

On 27 March 2011 Detective Inspector Parker commenced duties at Newcastle City Local Area Command as Chief of Investigations. As part of those duties I was responsible for managerial oversight of all investigation within the Command. This included Strike Force Lantle.

From this point the investigation progressed in a timely manner without further significant issue. While there were further delays associated with the investigation, these were not significantly different from those suffered during the course of any major investigation. These would include such issues as availability/reluctance of witnesses, analysis of voluminous information/intelligence, investigative delays and sick/annual leave. Any note worth delay has been documented within the Strike Force holdings, however, none would be deemed to have significantly affected the timeliness of the investigation.

Regarding the approaches made by Strike Force Lantle to Detective Chief Inspector Fox prior to 2 April 2012, interrogation of Strike Force Holdings indicates a total of 27 products associated with the name FOX.

After further review of these holding, eight products are considered to fit the criteria of the request. These documents are attached for your consideration. While some do not relate directly to contact with Detective Chief Inspector Fox, all are considered relevant as they reflect directly on the decision making processes, relating to the officer, conducted during the management of this investigation.

The final document included, is a record of conversation between Journalist Joanne McCarthy and Detective Inspector Graeme Parker, shortly after he assumed managerial control of Lantle. While this document relates to April 2011, it does show remarkable relevance to the current situation.

COMMENT:

The holdings of Strike Force Lantle are extensive. What has been supplied is merely the result of a search conducted across the investigation on the key word fox using between dates of 1/9/2010 and 4/4/2012. This should not be considered to be definitive as to contact between the Strike Force and Detective Chief Inspector Fox. It does not, for example, take into account any phone contact between officers associated with Strike Force Lantle and Detective Chief Inspector Fox that may have been recorded in individual officer's duty books, diaries, writing pads or any other means of contemporaneously recorded documentation. If these records have not been uploaded to E@glel, they will not be captured during the conducted search.

What is, however, quite apparent is the Strike Force's willingness to accept assistance from Detective Chief Inspector Fox, even when he appeared to display an absence of enthusiasm to do so.
