Asked did these belong to you or Fletcher? Stated "they were mine". I said "are you sure?" He said yes. I said: do you have them? Did James Fletcher hand them back to you? Stated yes he did and I have destroyed them. When is this all going to stop? It has hurt a lot of people. I said I would expect James Fletcher's trial about mid 2004. I said I am sorry for any hurt or embarrassment this has caused you. Have you ever seen any similar material in possession of Jim Fletcher. "I suspect he had some but I never saw him with it".
