MR WATSON: Just a couple of matters of housekeeping. Although it may have been foreshadowed that we were going to call Mrs Tennille Koelma today, we won't be doing that and she will not be called till Monday. Although we had foreshadowed tomorrow that we may call Mr Palmer, Troy Palmer, and Mr David Sharpe, we've decided that the book is already full, if we just stick with Mr Williams, Holly Hughes and Karen McNamara

THE COMMISSIONER: Yes.

MR WATSON: So Mr Palmer and Mr Sharpe will go over to Monday as well.

THE COMMISSIONER: Thank you.

MR WATSON: Thank you. Mr O'Mahoney will take the next witness.

20 MR O'MAHONEY: Commissioner, I call Mr John Caputo.

THE COMMISSIONER: Yes, Mr Caputo, if you could come forward please. Mr Kerkyasharian, you appear for Mr Caputo?

MR KERKYASHARIAN: With your leave, Commissioner, yes.

THE COMMISSIONER: Thank you. Yes, that leave is granted. You've explained to Mr Caputo the effect of an order under section 38?

THE COMMISSIONER: Could he be sworn please.

Just for the record I understand your full name is John Gennaro Domenico Caputo?---Oh, that's right, yeah, John Gennaro Domenico Caputo, yeah.

I was hoping you'd know that better than me but I understand, sir, you're both a valuer and a company director?---That's right.

And that you are also a real estate agent?---Yes.

And you work in latter capacity up on the Northern Beaches?---That's right.

Of Sydney. You are the vice president of the Manly State Electorate or SEC?---Vice President, Vice President, yes.

And you're President of the Allambie branch of the Liberal Party?---Yes, Allambie Brookvale branch.

Allambie Brookvale branch of the Liberal Party?---That's right.

You - we've got some evidence that there's a connection between you and Mr Tim Trumbull?---Ah hmm.

Is that correct?---Yes.

If I could show the witness a bundle of documents, Commissioner. I have some copies.

THE COMMISSIONER: Thank you.

MR O'MAHONEY: Sir, if I could ask you to turn to page 3976 of this bundle.

MR HENSKENS: I'm sorry to interrupt my learned friend, Commissioner, but could the bundle of documents be identified?

40 MR O'MAHONEY: It's, it's ---

THE COMMISSIONER: It's a bundle from page 3961 through to 3980.

MR O'MAHONEY: And I'll tender this bundle.

MR HENSKENS: Could I ask, sorry, Commissioner, have these documents previously been made available?

MR O'MAHONEY: They haven't, Commissioner, I was just about to tender them.

THE COMMISSIONER: Yes, thank you.

MR O'MAHONEY: I seek to tender this bundle, Commissioner.

THE COMMISSIONER: Yes, the bundle comprising pages 3961 to 3980 inclusive is Exhibit S39.

MR O'MAHONEY: Sir, if I could ask you to have a look at page 3976 I think that that's up on the screen - --?---Yes.

- - - as well for those following?---Yeah, I've got that, yeah, ah hmm.

This is an email from an employee at Taxback Australian, you understand that to be where Mr Trumbull worked?---Yes, that's right.

And it's to various internal email addresses at that company?---Ah hmm.

If I could just take you to the last couple of lines before the sign-off, "Thanks, kind regards" - - -?---Yes.

- - - and it's, the email's entitled "Telephone training" and it appears to be an email setting out some instructions for people within the office as to how to answer the phone, do you accept that?---Ah, no, I don't.

Well, "When answering the phone, particularly if it is for Tim, you need to make sure that you get all the details of who that person is and what they want."?---Oh, let me have a look at it. Let me read it again.

No, no, I appreciate that?---"If it's John Caputo (not transcribable) a member of the family Tim will always usually want to take this call unless he is busy." Oh, look, I'm not sure why - I don't know anything about that.

Okay. Well, it appears to be internal instructions with Mr Trumbull's workplace as to how the phone is to be answered but I just draw your attention to the last paragraph. "If it's John Caputo, Simon Williams, Lynn or a member of his family Tim will always usually want to take this call unless he is busy."?---Yeah, well, I don't know anything about that.

No. But I just, I just draw that to your attention - - -?---I understand what you're saying, yeah, I understand, yeah.

- - - provided by way of background. In that context it must be the case that you and Mr Trumbull had something of a close relationship?---I met Mr Trumbull through the Liberal Party um, we are friends, mutual friends for the Liberal Party.

And did you, I mean friends a broad church, sir, did you become quite close with Mr Trumbull courtesy of that acquaintance?

---Um, I wouldn't say close, no. We have coffee every now and then, we've had lunch.

THE COMMISSIONER: Do your families spend time together?---I beg your pardon?

Do your families spend time together?---I've been to dinner with Mr Trumbull and my wife and his wife, yes.

MR O'MAHONEY: Okay. Cast your mind back to 2011 to the best of your recollection how often were you in contact in any way with Mr

Trumbull?---Well to be honest with you I don't remember but I would - - -

Well that's - - -?---Maybe every, we've had coffees and we've had, I didn't know him that well because I only met him around towards the end of 2010 um, through the Liberal Party.

Mr Caputo, I'm not going to hold you to a number of minutes spent with Mr Trumbull in 2011 but broadly speaking was it once a week, was it once a day, was it twice a day, was it once a month?---Maybe once a month.

Once a month. And is it the case that from time to time Mr Trumbull made donations to the Liberal Party?---Yes.

And is it the case that in 2011 he made it clear to you that he wanted to make some donations to the Liberal Party?---Yes.

What were the circumstances in which he made that clear to you?---Right. He, he rang me up and he said to me that he wanted to donate to the Liberal Party.

40 Stopping there, is this early in 2011?---I think so, yes.

Yes?---Yes, yes.

Go on, what were the circumstances?---Um, he rang me up and said that he wanted to donate to the Liberal Party and um, he asked me who to make the cheques out to and I said Liberal Party Australia New South Wales Division and he said that when he was ready would come to my office and um, give the cheques.

Did he tell you why specifically he wanted to make a donation to the Liberal Party?---Yes, he said he wanted to get rid of this Labor Socialist Party.

I was going to ask you did he use the word socialist?---Yes, he did.

But he did, true to form he did and the, did he say to you how the, how he would like those cheques to be used to that end?---No, he didn't.

And he foreshadowed you said in that phone call that he was, he would drop off the, the cheques or come to you with a donation, is that what occurred? ---Yes.

And is it the case that he came to your office in Dee Why to achieve that? ---Yes.

And can you tell us what happened, he came to your office in Dee Why what, armed with some cheques?---Yes, look I can't remember exactly but I think he, he came in, I think he might have rang me up came in and gave me the cheques, yes.

And was that on one occasion, sir?---Um, he – on two occasions.

On two occasions. Both in - - -?---He gave me another lot later on.

Say that again?---He gave me another lot of donations at another time.

Does this accord with your recollection that in February 2011 he came and presented you with on 17 February a number of cheques?---Look, I think it's right, yeah.

And one of those cheques was in his name one was in his wife's name, one was in the name of a company skilled that he controlled, and another few cheques were in the name of employees that worked for him?---That's right, yes.

And that on 16 March does this accord with your recollection, a number of other chaques were delivered by him - - -?---Yes.

40 --- to you?---Yes.

30

Now were there any conversations that occurred upon, between you and him on delivering those cheques to your office?---Um, not really, no, he just said he wanted, again he said he wanted to get rid of the Labor Party Federal and State.

Well it's clear we understand what he desired but did he say anything about how these cheques were going to achieve that or what they were in aid of?

---Oh no, he just said that it would help the Liberal Party and I made sure that I told him that when, what he, when he rang me the second time I made sure that he, I, I made sure that he would, the cheques would be made out to the Australian Liberal Party, Liberal Party of Australia New South Wales division, I made that very clear.

Now something that must have struck you about these cheques was that they were as I have already indicated they were drawn by different people - - -? ---Ah hmm.

- - - and did you make any effort to get to know who the drawers of these cheques were?---No, only his wife and, and him.

So you didn't know for example who the employees were that had drawn these cheques?---No, I went to his office once and I think I might have said hello to one of the employees but I don't, didn't know them, no.

And is, is it the case that anything was done on your part at all to ensure that the people making out those cheques were not prohibited donors?---No, I told Mr Trumbull that developers could not donate um, hoteliers and poker machine companies, I made, I made that clear to him.

Okay. You made that clear to him - - -?---Yes.

--- but I'm assuming the cheques what – and if the answer's nothing ---? --- On what, sorry, what was that, sorry?

What steps did you take to ensure that the cheques that had been made up by people you didn't know were not made out by prohibited donors?---Well I didn't know, I didn't do anything about that.

Okay. And did Mr Trumbull say anything to you about, about how it came to be that he was handing you multiple cheques?---No.

Were you here yesterday, sir, when Mr Trumbull gave his evidence?---I was here.

And did you hear the evidence that was given about really the scheme that he devised?---I, I heard that, yes.

A fairly basis scheme you'd accept?---I heard that.

And you can see the, the risks that arises, sir, when a gentleman comes to you with a bunch of cheques and hands them to you and no effort is made to understand whether or not they're from prohibited donors or, or how they came to be, you can see the risk is that one individual might want to make a donation of \$20,000 but it barred from doing so, an easy way to do it is just

to get five compliant staff members and, and have them all write cheques for smaller amounts?---Yeah.

There's nothing scientific about that?---No.

Did you on hearing that evidence yesterday how did it make you feel?---Well, I wasn't aware of that so I, I didn't, I didn't, I didn't know that such schemes were, were around.

Did Mr Trumbull speak to you at the time of giving you the cheques and say something along the lines of listen I want to give an amount that is beyond the legal limit what I'm going to do is have a few staff members put pen to paper and we'll get a cheques together?---No, he didn't.

Didn't say anything along those lines at all?---No, not at all.

And on receiving the cheques, Mr Caputo, what did you do with them? ---Right. What we normally do is we sent them to our treasurer or we send them to head office and that's what we done with the cheques.

You say you, you ordinarily would send them to the treasurer or to head office?---That's right.

Okay. Well what we know about these cheques is, Mr Caputo, these cheques ended up in the hands of Mr Christopher Hartcher I think - - -

Well sorry, I take that back. These cheques we know were ultimately banked in, in a law firm, the trust account of a law firm Hartcher Reid. Is it the case that you presented these cheques at some point or gave them to Mr Christopher Hartcher?---No, I didn't give them, give them to Christopher Hartcher but as you, um, Mr Hartcher, excuse me, did ring me at some stage and um, he said he needed funding for the Central Coast and three cheques from Mr Trumbull went to Mr Hartcher's office.

Okay. And roughly to the best of your recollection when was that phone call made?---Look I, I cannot recall, I don't remember that.

But assuming you got these cheques in February and March of 2011 was it soon after receiving these cheques?---To be, to be honest with you I can't, I can't recall, don't remember.

THE COMMISSIONER: Mr, sorry, Mr Caputo, could I just clarify, you said that you would ordinarily send cheques that were made out to the Liberal Party to head office?---Liberal Party head office, yes.

Yes. Whereabouts in Sydney?---In William Street.

In?---William Street, Sydney, yes.

In William Street. And, and would you normally do that by putting them in the mail?---Yes.

So that would be something that you would have done by way of general practise within a week of receiving the cheques?---Within, within a week yeah, something like that, yeah.

So does that assist you to determine that the phone call from Mr Hartcher was probably in the space of about a week after the cheques were delivered?---Look, as I said I can't recall the phone call exactly when it was.

MR O'MAHONEY: You can't recall the phone call exactly when it was ---?---No.

- - - but we must assume probably within 2011?---Yes.

20

Well let's think about it, it had to have been between you receiving the cheques and the cheques making their way to the Hartcher Reid trust account, do you accept that?---Well I would say, yes.

And as best you can recollect, sir, and no-one's expecting you to recall word for word or holding you to a word for word recall of that conversation, what did Mr Hartcher say and what did you say to him?---Mr Hartcher said that he needed, the Central Coast needed funds and he asked me whether I was able to assist and I said I think I can and I did.

And what did he say about the need for funds on the Central Coast?---Um, from memory I think he said that for the campaigns.

Did he say that the campaigns were cash strapped?---Oh, he didn't say that, no, no.

Did he indicate there was a specific need for funds?---No. I don't recall.

And in response to that were you able to say, good news, I've got some cheques in the bottom drawer?---Well, I said to him, I said I was able to assist him, yes.

And courtesy of the fact that you had these cheques that you'd been given by Mr Trumbull?---Yes.

Mr Caputo, we've got some information that indicates that these cheques, we've got some information indicating that these cheques were earmarked for the support of Chris Hartcher at a much earlier stage, i.e. at the point of drawing. Were you aware of that, did Mr Trumbull say anything to you? ---No.

Well, tell us this, Mr Caputo. When you look at these cheques, they're made out to the New South Wales Liberal Party. Do you accept that? Yes. Oh, of course.

And you've spoken earlier about what the usual practice would be, about how they'd be treated?---Yes.

It appears here there's been a diversion from the usual practice, you have to accept that?---Well, no, it's not unusual, sometimes some seats require money so it has happened that we have given money to other seats.

There's a lot of questions coming from those few words, Mr Caputo. Who is we?---Well, you know, I'm talking, I'm talking about the Liberal Party, the, the conference, my conference.

Mr Caputo, moments ago you said the usual practice was for cheques made out to the Liberal Party to be sent to the treasurer or to headquarters? --- That's right, yes.

20 Here you've outlined a situation- - -?---But on occasions we- - -

If I could finish, Mr Caputo?---Sorry.

You've outlined a situation where an individual member has called you, said he needed support, and cheques made out to the Liberal Party have been sent to him?---Yes.

I'm just wanting you to accept, sir, that's a diversion from what you said was the ordinary practice?---Yeah, yes.

Do you accept that?---Yes, I do, yeah. But no, no, I want to say that um, it has happened in the past that if conferences, other conferences need, require funding, that we, it's happened before.

Okay. Could you just to the best of your recollection tell us some stories about where it's happened before?---Um, look, I can't recall.

Oh, come on, sir, just one example. If it's, if it's not that uncommon an occurrence, what campaign, what member?---Look, I do not recall.

Was it in respect of the State election in 2011?---Yes, it could have been, but I can't, can't recall.

And who else, who was another member or another branch that called up and said we need support, direct support?---Well, we had, we had calls from all branches, all, all conferences that wanted funds. Um, ah, Parramatta, all those, all those ah, ah, conferences.

Again you said "We had calls." Who's the we, who's receiving these calls? ---Well, look, I'm, I'm talking about Liberal, Liberal Party, my conference.

You're talking about- --?---Because I was the president at that time.

You're talking about the Manly conference?---Yes.

And did you get permission from the Manly conference to act in this way, to send the funds off elsewhere in the state?---Look, I, from memory I think I might have rang the treasurer and maybe one of the guys on the committee and asked them whether it was okay and ah, they, they had no problems.

Who was the treasurer of the Manly SEC?---Phil Young.

Say that again?---Phil, Phil Young.

And who were the members of the committee you might have run it by? ---Um, could have been Walter Villatora from memory.

Okay. And it seems that this wasn't a one-off, that i.e. the sending of money to assist Mr Hartcher, you've had a few more minutes to think about it. Just give us another example of someone else who requested fund?

---Um, there was a fundraiser ah, and we had ah, for the Central Coast and there were other funds going to there which I saw on the screen yesterday and I also saw there was certain cheques that went also, I think it was three or four, I can't remember.

If you have a look at that bundle of documents in front of you- --?---Ah hmm.

---there is in there at page 3972, this is a document, it looks like a flyer or a brochure, and in red at the top it says, "John Caputo, President of the Manly Conference Liberal Party of Australia New South Wales Division invites you to a dinner with special guests, the Honourable Chris Hartcher, Shadow Special Minister"- --?---What number's that, sorry, what, what- --

3972. It's on the screen, Mr Caputo?---Oh, yeah, yeah, yeah.

Just, it just looks to be an invitation, but it's you as President of the Manly 40 SEC- --?--That's right.

---making an invitation to a dinner with these special guests who were Mr Chris Hartcher and the Honourable Greg Smith. Do you see that?---That's right, yes.

To be held at the Sheraton On The Park?---That's right.

The date, 24 March, 2011?---Yep.

Dress, lounge suit. And down the bottom it looks like you're the, the person, the go-to person for the making of cheques?---That's right.

Now, you said moments ago that there was another occasion where some moneys, some cheques were sent up to support the Central Coast?---That would have been this one here.

And this one here?---Yeah.

10

Now, just about that, how many people roughly attended this dinner, Mr Caputo?---Ah, probably about 12 or 15 people.

And what would they have paid per head?---Um, some paid 500, some paid 900, some paid 1,000.

So roughly, and I know you haven't got a calculator in front of you, but what was the total take from this event?---Um, look, I can't remember exactly but could have been five, eight, 10,000, something like that.

Okay. Was this, it was a success?---It was good, yeah.

And is it the case that the money raised, that eight to 10,000, obviously there would have been some expenses with the booking and so forth- --?---Yeah.

- ---room hire, but is it the case that those moneys were sent up to the Central Coast?---Ah, some was, some of the money was, it was done through head office actually.
- Okay?---We sent, we sent some cheques directly, I think some cheques that came after the event we sent to the Central Coast.

Okay. Roughly what amount was sent to the Central Coast?---Look, I can't remember exactly, five, five or 6,000, something like that.

And I've got to ask you again, you said, "We sent some cheque, roughly five or 6,000 to the Central Coast." Who is the we?---Yeah, well, um, I shouldn't say we, I sent them.

40 Okay?---Yeah.

You're speaking about yourself in the plural?---Yes.

But you also seem to be talking about getting permission from headquarters, from the Liberal Party head office, you've said that a couple of times. Who were you speaking to at the Liberal Party head office?---Um, what, sorry, can you repeat the question?

In response to a line of questions about the moneys, the cheques that were sent up to the Central Coast, you said words to the effect that you ran it by, it was done through head office?---It wasn't head office, no, it was my conference, like my committee of the conference, not, not head office.

Okay. So did you get permission from the head office of the Liberal Party to send funds raised from this function to the Central Coast?---(No Audible Reply)

Surely you would have had to run it by them?---No, I, no, because this, this function was for the Central Coast, so, so it wasn't ah, we didn't, Central Coast, the head office knew about this function.

But again, consistent with the cheques that we've been discussing earlier, those made out by Mr Trumbull and his cohort, on this page it indicates the cheques were to be payable to the Liberal Party of Australia New South Wales Division?---That's right, yes.

Surely you have to get permission from the New South Wales Division to have cheques made out to it- --?---No, but that fundraiser was for the Central Coast so they knew about that.

So they knew about that. Who knew about that?---Ah, the deputy director of the, of the State Liberal Party.

And who was that at the time, sir?---Look, I can't recall exactly. There have been so many changes I can't think of his name.

Okay, well, just cast your mind back. Who was, who was the person who would have been aware of that and signed off on that?---I don't think he had to sign off but I can't, I can't think of his name.

Who else would you have spoken to about this arrangement, i.e. cheques made out to the Liberal Party of Australia New South Wales Division being sent to the Central Coast, who else at Liberal Party head office?---Just the, just the deputy director.

Of finance?---Yeah.

Was it a gentleman by the name of Simon McInnes?---Oh, look, I'm not sure whether I spoke to him, I could have spoken to him but it was someone which is the deputy director and I think Simon McInnes is the financial director.

And can you picture the man as you're sitting there today?---Sorry?

The person we're talking about whose name you can't recall, can you picture him?---Um, look, I've, I've met him a couple of times, yeah, but I mean I, I just can't think of his name.

And paint a picture for us as best you can, what does he look like, how old was he?---Probably about 40 years of age.

And anything about his appearance that struck you?---No.

10 Just a normal-looking guy?---Yes.

Who happened to be the deputy director of finance?---No, no, no, deputy director of the Liberal Party.

Deputy director of the Liberal Party?---Well, he's, he's the deputy, they have a general manager and he's the second-in-charge.

Well, I just want to be clear about this because we obviously might need to speak to this person?---Ah hmm.

But we're talking about someone who was the deputy director of the Liberal Party as at March 2011?---Yes.

And what did he say about this idea of sending cheques made out to the Liberal Party of Australia New South Wales Division to the Central Coast? ---This was a fundraiser in particular for the Central Coast.

No, that's not an answer to my question, sir?---Yeah, yeah. I mean I'm not sure, look, I don't know what he said, I don't know what he said, but this, this---

But did he say don't do it?---But this, this - I beg your pardon?

Did he say don't do it?---Sorry?

Did he say whatever you do don't do that?---No, no, no, no.

Did he say please do it?---No, he didn't say that at all, no.

Well, what did he say?---I, I can't recall what he said.

MR KERKYASHARIAN: Can I, can I object here, Commissioner? I don't think that this witness has said that that conversation has occurred. I don't think he said that - - -

THE COMMISSIONER: He said, he said he spoke to someone who he described as the Deputy Director other Liberal Party as at March 2011.

MR KERKYASHARIAN: I accept that, Commissioner, but I don't think he said I asked him specifically about speaking to - - -

THE COMMISSIONER: Well, no, I know, I know he hasn't given evidence of what the conversation is but that's what the questions are directed to.

MR KERKYASHARIAN: Well, I just - it seems to be that they're presupposing that that part of the conversation's occurred without putting that to him.

THE COMMISSIONER: But he'd have to have spoken to somebody in English words. I think what we're trying to get at is what was said more or less but can we, can we just move on.

Mr Caputo, we're not expecting you to remember word for word what was said but you had a conversation with someone about the destination of these cheques that were written out for the purpose of this dinner. What, what was the effect of the conversation?---Look, as I said, I, I - Commissioner, I can't recall exactly what happened but this, this fundraiser was, was made for the Central Coast and, you know, that - I can't say much more than that.

MR O'MAHONEY: Okay. Well, can you just tell us, sir, looking at this page, 3972, what is it, just take us to the text on that page that would make someone attending this dinner realise that this was a function that in your own words was always for the Central Coast?---The - on the night of the, on the night of the ah - - -

No, if you wouldn't mind, is there something on the page that indicates that? ---No, there isn't.

Could I take you to another document in that bundle at page 3978, Mr Caputo. This is an email exchange and you'll see that it starts as always with an email at the bottom, it looks to be a pro forma type email from you sent to Mr Trumbull on 23 December, 2011 wishing him and the family a Merry Christmas and good health for the New Year?---That's right.

You see that?---Yeah, yeah.

And then you've got a response that certainly isn't pro forma. "Dear John and Leticia, wow, John, what a wonderful year it's been in 2011. You are an endless ball of energy in your endeavours to help so many others." Do you see that?---(No Audible Reply)

This is Mr Trumbull celebrating your work in 2011. He then makes some mention of the Manly Lifesaving Club, do you see that, thanking you for your support?---Yes, I do that, yeah.

And then - and by the way, did you know, did you have a connection with Mr Trumbull through that lifesaving club?---No.

Are you involved in any lifesaving club?---No.

But I think I have a recollection that Mr Trumbull was incredibly passionate about the, the state of the, the - I think the clubhouse at Manly, is that right? ---Yes, he was, yes.

Particularly I think he had a problem with the men's changing room?---He had a problem with - yes, yes, yes.

If I could then take you to the, the paragraph beneath that where it says, "Congratulations on your appointment as chairman fundraising of the National Conference of the Liberal Party," you see that?---Yes.

What was that role, Mr Caputo?---Well, that's word, that wording's wrong, it's not the, not the right wording. Um, I'm the chairman of the ah, Warringah Federal Conference, chairman, chairman of the ah, fundraising committee of the Warringah Conference.

And who were your main points of contact at that time in 2011 at the State HQ, the head office of the Liberal Party?---Well, I have spoken to Simon McInnes a few times but ah, the, the second, the guy that um, ah, that I spoke to was the deputy um, the deputy of - - -

The Deputy Director?---Director, that's right.

But you've spoken to Mr McInnes. Would you have ever spoken to Mr Nicolaou, do you know Mr Nicolaou?---Yes, I do know him.

How well do you know him?---Oh, I know him but I don't know, I've never spoken to him about ah, this sort of stuff, no.

Out of interest why not? He would have been, he was, he was certainly central to the Liberal Party's fundraising efforts wasn't he?---Yes.

And why was it that you never spoke to him about this sort of stuff, ie, fundraising?---Well, I had, I had nothing to do with the - he was in charge of the Millennium Forum I believed and ah, I had nothing to do with that.

So it wasn't the case that you would interact with him given his back story in fundraising?---No, not at all.

In respect of your fundraisers?---Not at all.

Now you mentioned that the reason we looked at this, the flyer for this other dinner that resulted in cheques - - -?---Yes.

- --- I think you said six to \$8,000 in cheques ---?---Something like that, yes, yeah.
- - being sent to the Central Coast, I was asking you some other examples of the normal practice being diverted from - -?---Yeah.
- - can you think of any other examples of that practice being diverted from?---No, I can't but as I said this, this fundraiser was done for, for the Central Coast. On the night of the, on the night of the dinner that we had ah, the, the ah, people that attended um, it was mentioned that it was for the Central Coast.

Okay. But, but were cheques ever sent? You can't maybe recall a specific other incident of the normal process not being followed but were cheques ever sent to a region outside of the Central Coast, to the south or to the west?---Not, I can't recall.

When you say that you sent six to \$8,000 to the Central Coast could you flesh that out a little bit. How did you go about doing that?---The money was banked, was sent to the head office and there were some cheques, I think which we received after that were sent to ah, the Central Coast.

Could you just lean forward a bit, it was hard to hear the answer?---Yeah, sure, sure.

Okay. There's a few steps there. You said the money was sent to head office?---Yeah.

Who did you send it to at head office?---It was sent to the, to the director and the Treasurer I would say.

And who were those two persons?---Ah, I think it was Simon McInnes from memory, yeah.

Okay. And was Mr Sinodinos the Treasurer at that time?---I'm not sure, I don't remember. It was, I know that he was the Treasurer at some stage.

Did you speak to Mr Sinodinos about your fundraisers?---No.

Never?---No.

Even if he was the Treasurer?---No, why would I have to speak to him for?

Well, I thought you just said you sent the cheques to the Treasurer and the director?---No, no, no, the director, the Director of Finance.

And you said the Treasurer?---Oh, I do apologise, that's, that's not right.

Well, have you said, have you taken that back because I mentioned Mr Sinodinos?---No, no, no, it's nothing to do with the Treasurer, it was the Director of Finance. Mr, Mr Sinodinos wouldn't deal with money, it would be the Director of Finance.

Sorry, did you just say Mr Sinodinos wouldn't deal with money?---Well, he doesn't receive - - -

Wasn't he the Treasurer?---Yeah, but he doesn't receive the money, it goes to head office.

Okay. But (a) he was the Treasurer and (b) moments ago you said in response to who did you send the cheques to you said that the director and the Treasurer?---No, no, I do apologise, that, that - I made a mistake.

Okay. Well - - -?---Just that it would have been the finance director.

You, you say that the cheques were sent to Liberal Party HQ?---That's right.

20

And then what happened?---They, they would have been sent, that money would have been credited to the ah, Central Coast ah, conferences and they, they would ah, then send them - they would credit them to the Central, Central Coast Conferences, yes.

Mr Caputo, that strikes me as a pretty vague answer. Let's talk about what did happen not what would have happened. You know the money, you say six to \$8,000 ended up on the Central Coast?---Something like that, yeah.

- Okay. We're not holding you to the exact dollar figure, sir - -?---Yeah.
 - - but I want to understand how it came to be that that occurred?---Yeah, the money that I received - -

The money from the Liberal Party headquarters - - -?---Ah hmm.

- - did you have a discussion with Liberal Party HQ along the lines of this money has to go to the Central Coast?---Yes, I did (not transcribable) yes.
- Okay. Now who was that discussion with?---Yeah, I think it was with the Deputy Director.

The man with, with no face or name?---Yeah, yeah, I can't think of his name

Was he tall or short?---Um, I'm not actually - I think he would have been about ah, just in between I suppose.

I don't want to offend him but was he chubby?---No.

Was he a gregarious sort of guy?---Look, I'm not sure, I didn't know him that well.

You're obviously incredibly well connected with the Liberal Party, is that right?---Yeah, yes, I am.

Well, is it the case that you could ascertain the name of that man within 10 minutes if we gave you a phone and a little bit of time to yourself?---(No Audible Reply)

Could you work out in the box if we gave you 10 minutes now to work out who this person is?---(No Audible Reply)

If we gave you a telephone, I've never done this before but my, my leader's saying give you phone, could you make a couple of calls and work out who the name of this person is?

20 MR KERKYASHARIAN: I object to that.

MR O'MAHONEY: Well, on what basis?

MR KERKYASHARIAN: Well, how does he know who's going to pick up the phone or that anyone's going to pick up the phone?

THE COMMISSIONER: Well, I don't know but he could, he could ring somebody in the Liberal Party who keeps records of who the officeholders were in 2011 I would have thought.

MR KERKYASHARIAN: Well, I would have thought the Commission can do that, I mean - - -

MR O'MAHONEY: Well, do you want me to make the calls for you? ---Well, look, look, the thing is if, if you ring Liberal Party headquarters they'll tell you who the Deputy was in 2011. I mean I don't really know, why, why this is relevant.

Mr Caputo - - -?---I don't understand what you're saying.

40

Well, Mr Caputo, your barrister's concerned about who's going to pick up the phone and I could screen the call for you but I'm saying we've seen evidence that you're incredibly well connected within the Liberal Party, you've been involved in fundraisers, we've got an email here congratulating you on becoming a chairman of a fundraising entity. You've forgotten the name, sir, of someone who is quite important to this investigation and I'm saying in the context of your connections you could be able to work out who that person was within minutes. Is that the case?

---Look - - -

Yes or no?---I can, I can make some phone calls there's not a problem but I think if you want to um, you can, you can check out – it's not a problem to um, find out from Liberal Party headquarters who the deputy director was.

THE COMMISSIONER: Mr, Mr Caputo, can I clarify something, you said, you said it was the deputy director of the Liberal Party as at March 2011 - - -?---Yeah.

--- is that deputy director of the State branch?---State branch, State branch, yes, State.

All right. So it's the deputy director of the State branch of the Liberal Party in March 2011?---That's right, yes.

And, and then in answer to some questions further you said that you sent the, the cheques from the fundraising dinner to the director of finance, was that also the State branch?---State, yes.

Isn't that right?---Yes.

And then you said that the cheques were credited to the Central Coast conference, is that what you said?---That's right, yes.

Do you mean to say that it was the director of finance who took that step namely to credit the cheques to the Central Coast conference?---Well he would have done that, yes.

When you say he would have done that why would he do that, is that because you gave him some kind of instruction?---Well the money that we raised for that function was for the Central Coast campaign.

Well did you, is what you told him that they - - -?---Yes, yes.

--- they were to be credited in that way?---Yes, that's right.

And then do you say that, that all of those cheques came back to you or only one cheque came back to you or - - -?---Some, some, some cheques came later on and the ones that I, I received later I sent to the Central Coast.

No. But I thought you were indicating that after the director of finance credited the money to the Central Coast conference some of that money came back to you?---No, no, no, no, definitely not, no, no.

All right. Well we better clarify that 'cause - - -

MR O'MAHONEY: Yeah. There's a few things I'd like to clarify, Mr Caputo?---Yeah.

I mean just thinking out loud, you can't send a cheque to the Central Coast, I mean that'd be like sending a cheque to Penrith. Who was the cheque sent to, these cheques?---It was sent to the, Chris Hartcher's office.

Okay. Addressed to Chris Hartcher?---Look I can't - - -

Well who else would you have addressed it to?---I would say so, yes, I think so.

Now so you had a conversation. Now is the person you had a conversation with, we might be able to save you a phone calls and we might be able to stop you having this evidence stood over, was the person without a name thus far a Mr Richard Shields?---Yes.

Okay?---Sorry, I couldn't, couldn't remember the name, yeah, that's it.

20 And apologies to Mr Shields for the non descript - - -?---Sorry.

- - - reflections on his appearance. But, but can I say this you had this conversation with Mr Shields and you said to him the cheques need to go to Mr Hartcher's office?---No, no, I - - -

MR KERKYASHARIAN: Commissioner, can I – this, this - - -

THE COMMISSIONER: Well we're trying to find out what was said.

30 MR KERKYASHARIAN: I understand that.

THE COMMISSIONER: There's no objectionable aspect to the question.

MR KERKYASHARIAN: Well, Commissioner, which cheques? He's given evidence - - -

THE COMMISSIONER: Well that's what we're trying to find out.

MR KERKYASHARIAN: Well I'm sorry, Commissioner, he - - -

THE COMMISSIONER: I'm sorry, we don't know because we haven't had any clear indication of whether there was one or more and where they were sent and to whom they were made out.

MR KERKYASHARIAN: Well can I suggest perhaps that that's the better inquiry because he's already given evidence that some of the cheques went to head office and others went to the branch and it's being asked as if all of it went to the same place - - -

MR O'MAHONEY: Mr Caputo, just to back step a couple of steps for the assistance of your Counsel you've indicated that we're talking about this fundraiser that was held at the Wentworth Hotel?---Yes.

10 It raised maybe - - -?---No, that the Sheraton Hotel.

Sheraton Hotel. It raised maybe \$10,000?---Whatever, yeah.

You say six to eight approximately - - -?---Yeah.

- --- was sent to the Central Coast. We're talking about those cheques aren't we?---Those cheques, you're talking about I said seven or 8000 we raised altogether on the night. Right.
- Yes?---That's what I said. And some of the cheques that we received later on we sent, I sent, not we, I sent for the Central Coast to Mr Hartcher's office.

I want to be clear about this, are the cheques we're talking about the cheques in respect of the dinner that we've been talking about?---Yes.

Some were?---Yes.

Well you - - -?---And some people paid afterwards.

All right. So let's just deal with the cheques that were handed over at the dinner?---Ah hmm.

They were made out to the Liberal Party of Australia - - -?---Yes.

- - - New South Wales division?---Yes.

Were those cheques – how many of them were there, six, seven, eight?---I can't, I cannot remember.

Were there a number of them?---Yes.

Were those cheques the physical cheques sent to the director of finance in William Street, Sydney?---(No Audible Reply)

Were they or were they not?---No, they weren't.

Well I could have sworn that about five minutes you said that you sent to the director of finance those cheques which were credited to the Central Coast conference and then some of them were returned to you, I thought that's what you said?---No, no, no, no.

All right. Well let's start again?---Okay.

February 2011. What was the- -- ?--- Possibly December, something like that, yes.

What was the occasion?---It was a fundraiser for, again for the Central Coast.

That's clear, but give us a little bit by way of detail. Was it a dinner, was it a lunch?---It was a dinner.

Was it a dance?---Yeah, dinner.

It was a dinner?---Yes.

And where was it?---Um, at the Sheraton.

At the Sheraton?---Yes.

And how many people attended that dinner?---Probably 10, 12.

And what was the sort of price of entry?---Um, between 500 and 1,000.

How much was raised?---Um, I can't remember exactly, maybe 5,000, 6,000.

And how was the, how were the spoils of that dinner divvied up, was, was some money again sent to the Central Coast?---I think that money was all sent to the head office from memory.

All sent to the head office. But we know that some of the money that is sent to head office has found its way to the Central Coast, was it the case that that's what occurred- --?---I think so, yes.

- - -in respect of that dinner?---I think so.

Well, just casting your mind back, what conversations did you have with head office in respect of that dinner?---I don't recall.

You don't recall who you spoke to?---I think I spoke to again the deputy director, Mr Shields.

Mr Shields?---Yeah, but look, I can't recall exactly, yeah.

And you said that, what, the money needed to go up to Mr, he was guest of honour at the dinner- --?---To the Central, Central Coast, yes.

And who else, what other politicians have you organised fundraising dinners or lunches or events for?---When was this?

Oh, let's just think around the time of the 2011 election?---Mike Baird, as a, he's, he's actually the ah, Member for the (not transcribable) conference ah, what else um- - -

Well, in respect of Mr Baird would you have ever, after a fundraising event, have handed him cheques that were raised in that night?---No, no, we had our treasurer and he, he handled all the money, our treasurer in the conference.

What did you say, he earned all the money?---I said no, he---

THE COMMISSIONER: He handled all the money.

MR O'MAHONEY: He handled all the money?---Handled all the money, the treasurer, yes.

Okay, but I thought you gave evidence earlier that Mr Hartcher was handed some cheques at the end of a dinner?---Yes, because the treasurer of the conference wasn't there, of the Central Coast conference, so he would have, Mr Hartcher would have given those to, to his treasurer at the, of the Central Coast.

Sorry, that's as clear as mud to me, Mr Caputo. Did you say that normally the treasurer would handle the money but he wasn't at the dinner that Mr Hartcher was in attendance at?---That's right, yes.

How long have you known him for?---Um, 15 years maybe.

And when did you first meet him?---Um, probably at a Liberal fundraiser 15 years ago.

And did you become friends on the back of that political acquaintance? ---Yes, we became friends, yes.

How often as at 2011 would you have been in touch with him?---Oh, I'm not actually sure, you know.

No, again- -- ?--- Three or four times, maybe five times, I really don't know.

What, three or four or five times in the year?---You said in the election, during that election.

No. In 2011 were you in touch with Mr Hartcher once a week, once a day, once a month, twice an hour?---Maybe once a month.

Okay. Once a month. And the – you mentioned before that you'd been involved in other fundraisers for politicians, what other politicians have you raised funds for?---(No Audible Reply)

Again let's focus in on this March 2011 election?---Yeah, sure. Um, I don't think there was any others, no, I thought there was, but no, there isn't.

Okay. You did say however, sir, before there's nothing unusual about handing cheques over to the guest of honour at the end of a fundraising dinner?---That's right.

That suggests you've done it before, you know it's been done before. Could you just give us some examples of, of when that's occurred?---I, I can't, don't recall.

But hold on – is that a serious answer?---Yeah.

No, no, sorry?---Yeah.

Mr Caputo, 10 minutes ago you said it's not unusual. That squarely suggests- --?---What, what, what is wrong- --

No, let me finish, Mr Caputo?---What is wrong with giving- - -

Let me finish?--- - - a cheque- - -

Can I just ask you this. You said earlier that it was mentioned that the dinner was fundraiser for the Central Coast. Was there some announcement made or was that something that just occurred through- --?---Yes, no, no, we, yeah, we- --

- - -conversation at the table?---No, we made a, yeah, I made an announcement.

You made an announcement?---Yes, yes.

MR O'MAHONEY: Was there an announcement along the lines of, ladies and gentlemen, at the end of this dinner tonight I'm going to be handing certain cheques to Mr Hartcher?---No.

Well, it sounds a bit like a fraud, doesn't it, Mr Caputo?---No.

Well, cheques are being made out to the New South Wales Division of the Liberal Party and you're saying that you've got no problem with those cheques being handed over to a specific Member of Parliament at the end of the dinner, but the cheques weren't made out to Mr Hartcher or his campaign?---No, but the cheques would be banked in a conference um, and they were made out to the Liberal Party of Australia so they would have been banked in the ah, in, in the conference bank account.

But let's just, I mean I'm just – pretend I'm an average punter who's in attendance at this dinner – well, I'm not that average, I've spent 500 bucks to get there?---Yep.

But I've written a cheque to the New South Wales Division of the Liberal Party?---Yep.

And I find out years later that that cheque was put in the pocket of Mr Hartcher later that night. I mean you could imagine someone might not be

very happy to hear that?---It wasn't, didn't go in his pocket, he would have given it to his conference.

In his wallet?---Oh- - -

Well, I mean where was it put?---Oh, look, I don't know where it was put, I mean I don't, I don't think that question's relevant.

Well, you said it wasn't in his pocket, it sounded like you know, you knew exactly where he put it. No, could you answer my question?---Can I say that---

How would someone know- - -?---Can I say- - -

- - the cheque was going to go to Mr Hartcher, it was made out to the - ?---It doesn't- -
- - New South Wales Division?---The people that were there that night, there was an announcement made that that money, that money would go to
 the Liberal Party of Australia New South Wales Division and would be, would, would be going for the campaign for the Central Coast.
 Right. So if I gave, if we gave, if I gave Mr Hartcher the cheques, I would presume they would- -

Well, guess what, sir, that's exactly what didn't happen. It appears that money didn't go to the New South Wales Liberal Party?---Well, which money?

The money that was raised?---Oh, that's not true.

30

Okay. Well - - -?---I don't think its right. I mean, you know.

Okay. Well, let's talk about - - -?---Well, tell me which money - can I, can I ask you a question? Which money are you talking about?

It's an old fashioned system, I'll ask the questions, you answer them,
40 Mr Caputo. Can I ask - - -?---Well, can you clarify that?

Yeah, I will. Let's talk about the money that was, the cheques that you were given by Mr Trumbull?---Yes.

Do you recall those cheques?---Yes, that's - - -

Okay. Again - - -?---I'm pleased that we're going back to that.

Okay, I'm pleased you're happy about that, sir. We're talking about those cheques. They were like the cheques from this dinner made out to the New South Wales division of the Liberal Party, correct?---Yes, yes.

Yet they ended up on the Central Coast?---Yes.

In Mr Hartcher's office - - -?---Yes, I believe so.

- - - addressed to Mr Hartcher?---Yeah, yeah.

10

40

Now we know those cheques far from going to the New South Wales division of the Liberal Party ended up in the trust account, sir, of a law firm on the Central Coast Hartcher Reid?---Yes.

But not only that, they were then transacted further, sir, I mean they're pretty well-travelled cheques aren't they? They're exhausted by the time they get there?---Looks that way, yeah.

It looks like they were then used as payment in respect of IT services to a company known as Mickey Tech?---Ah hmm.

Well, that's exactly what didn't happen, that this money arrived at the New South Wales division of the Liberal Party?

MR KERKYASHARIAN: Well, I object to that. We're talking about two different sums of money. We're talking about the dinner before and now we're talking about the - - -

THE COMMISSIONER: That's precisely right, we are talking about a different sum of money.

MR O'MAHONEY: There's no doubt about that, Commissioner.

THE COMMISSIONER: And the witness understands that, the witness said he was happy that we were returning to the subject of the cheques that came from Mr Trumbull so go on.

MR O'MAHONEY: Do you accept that's exactly what didn't happen, that the money - you said earlier you took comfort in the fact that the money went to the New South Wales division of the Liberal Party. Here although the cheques were made out to that entity well, gee, they were, they ended up at a place far removed from that didn't they?---That's right, from the evidence I've seen, yes.

And you seem fairly relaxed about that. I mean - - -?---Well, I, I saw the evidence yesterday and I've seen the evidence that you've given already and I - it's obvious that that's what's happened, yes.

But, but I mean how can you be nonchalant about that? That's fraud isn't it?---I beg your pardon, sorry?

That is a fraud?---Well, yeah, it's not, I'm not - I wasn't aware of that ah, ah - that was happening at all, I had no idea. The money as I said was made out to the Liberal Party and I would have presumed it would have gone to the Liberal Party.

But let's just look at those Trumbull cheques. There's a fraud going on a the drawing end at the level of Mr Trumbull and his staff, do you accept that?---Ah hmm. Well, I, I accept what happened yesterday, what, the evidence that he gave, yes.

Was that - do you think that was a fraud, what was going on at that - - -? ---Well, yeah, yeah, it wasn't, wasn't right, yeah.

Okay. And at the final end with all funkiness around the, the deposit into the Hartcher Reid trust account - - -?---Ah hmm.

20 --- the Mickey Tech, there was a fraud going on at that end as well, wasn't there?---Well, it appears that way, yes.

And you were in the middle of it in the sense that you were the conduit? ---Well, the, the cheques that went to the Hartcher Reid whatever had nothing to do with me. I mean, I wasn't aware of anything like that.

Did Mr Hartcher ever say anything to you along the lines of there's this law firm I know on the Central Coast and god it knows how to deposit cheques well - - -?--No.

- - - and I'm going to end up putting the cheques in - - -?---No.

- - - through there?---No.

30

Did he ever mention a company called Mickey Tech?---No.

Okay. The reason I took you to those - - -?---I never heard of Mickey Tech because I - only through the papers, I've never - - -

40 The reason I took you to those two frauds a moment ago, sir, and I said you were the conduit, not in the sense that you were involved in either of them really, you could have been the innocent victim of both, we don't know, but the reason I took you to both of those was you were nonchalant about the fact that you were in the middle of it. I mean how does it make you feel to find out that, that you received these cheques fraudulently, you handed them over to a Member of Parliament who was arguably even more fraudulent with them, how do you feel about that?---Well, ah, I - as I said I wasn't

aware that that was - yeah, of course, it's not a good look at all, it's very bad.

That's it?---Well, yeah, I'm not, I'm not happy at all.

Have you - is it something that you've taken up at all with Mr Trumbull? ---No.

Have you received any cheques from Mr Trumbull since these cheques?

---No.

Have you given any cheques to Mr Hartcher since the election of March 2011?---No. Um, yes, ah, those, those cheques um, when did they go, I'm not actually sure when, when those cheques went to him um, there would, there would have been cheques to, after the election, yes.

Well, what other arrangements did you have with Mr Hartcher vis-à-vis fundraising?---Well, what do you mean by that, sir?

Well, in the history of your relationship with Mr Hartcher what else have you done to assist him as a fundraiser?---Nothing else.

Nothing?---No, those two, those two fundraisers there.

They're the only two events?---Yes.

At that second dinner we were talking about moments ago - - -?---Yes.

- - - or at either dinner were there, was there a raffle?---No.

30

Was there, were there any other means of fundraising?---No.

No silent auction?---No.

And can I ask you this, courtesy of your connections within the Liberal Party and your pretty esteemed back story as a fundraiser for it, you must have been aware of the Free Enterprise Foundation?---No, I was not.

Never been aware of that?---Never.

40

When did you first become aware of it, sir?---In ah, ah, when I saw it in the paper.

Is that right?---Yes.

So this huge donor, I mean we've been talking about today, sir, events that occurred in 2011, you accept that?---Yes.

As at that time and the years prior this was one of the largest donors to the Liberal Party in New South Wales, it was also a huge Federal donor to the Liberal Party, do you accept that?---Well, it looks that way, I, I don't think - as I said I don't know anything about it, never heard of it except through the papers.

How often were you talking to head office about fundraising in 2011?---Ah, I'm not sure, maybe a couple of times a month, I'm not really sure.

10 Who were you speaking to mainly?---Um, Mr Shields.

And when you became chairman of this fundraising entity in 2011 do you say that you never were made aware of the Free Enterprise Foundation? --- That's right.

And on becoming aware of it have you made any inquiries about it?---No, I only heard about it recently, through the papers.

The last few weeks?---Yes.

20

30

So, but that's what I find curious. You know, you are a very serious fundraiser for the Liberal Party, you've been so for some time and you suddenly discover that at the time you've been raising funds there's someone out there donating these huge sums of money to the Liberal Party. Wouldn't you on the back of becoming aware of that just made some inquiries with some colleagues?---I've only done it through the Warringah Conference, the Warringah Conference, I am, I am the chairman of the Warringah Conference ah, chairman of the fundraising committee, not the Liberal Party of Australia, New South Wales Division so it's just the local Conference of Warringah so ah, that's had nothing to do with me and I - - -

THE COMMISSIONER: Mr - - -?--- - and I said I'd never heard of it before.

Mr Caputo, can I just ask you something? Given your occupation as a fundraiser within the Warringah Conference - - -?---Yes.

--- you would I assume have had some interaction with Federal Members in that area such as the current Prime Minister?---Yes.

40

And he's a Federal Liberal Party politician?---Yes.

And despite all of those contacts no one has ever referred you to the, to the, the FEF, the - - -?---The what, sorry?

- - - foundation that Mr - - -

MR O'MAHONEY: Free Enterprise Foundation.

THE COMMISSIONER: The Free Enterprise Foundation?---No, I never heard of it, never, never heard of it.

MR O'MAHONEY: And on hearing of it just not interested, didn't want to find anything out about it?---No, I think it's very serious, no, I mean, I was listening to the, to the ah, hearing yesterday and, yeah, it's unbelievable - - -

Well, there's no doubt it's very serious but - - -?--- - - what's happened, very serious.

- - - not serious enough to make you want to call a colleague and say, well, what's going on, I've never heard of this entity, what's the story with it?
---I mean, it's got nothing to do with me, it's got nothing to do with the, our Conference.

But you're a fundraiser for the Liberal Party, sir?---Yes, that's right.

Well, it's not a great reflection of anyone doing that?---It's only, it's only, when did it come out? A few weeks ago in the papers.

That's right. Well, how long does it take to make a phone call? Mr Caputo ---?---Oh, that, look that question is unfair, I mean, I, I ---

I'm just curious as to why you haven't made any inquiry as to this entity? ---Where would I make the inquiry? I mean, it's got nothing to do with me or our Conference, this is something with head office you're talking about.

Mr Caputo, could I take you to a document, if the witness could please be shown Exhibit S8 at page 2419. If I could get you to look at page 2419 and you'll see there's a deposit slip from Westpac Bank on that page?---2419. Yes, I can see that.

Now you'll see that on that page, that's a deposit slip for a number of cheques - - - ?---Yes.

- - - and at least one of the cheques is on the pages over.---Ah hmm.

We've got some information that a cheque was banked by a staffer or four cheques were banked by a staffer in Mr Spence's office on 2 December 2012, I want you to accept that and that amongst those cheques were a cheque that had been drawn by Mr Tim Trumbull, we've been talking about today.---Ah hmm, yep.

Have you been able, did you act as a conduit between we'll call it a Trumbull cheque and Mr Spence?---No.

THE COMMISSIONER: It was 2 December, 2011.

MR O'MAHONEY: 2 December, 2011, yes Commissioner.

THE COMMISSIONER: Thank you.

MR O'MAHONEY: So you've never been, you've never presented any, done any fund raising for Mr Spence?---No, it was done for the Central Coast, what we've done was for the Central Coast, not for Mr Spence in particular, no.

10

But you were, it sounds like Mr Trumbull was making donations through you, is that correct?---I mentioned to you the cheques that he gave me and yes.

Did he ever mention to you that he was giving cheques to the Liberal Party through anyone else?---No.

But as it is, you don't know anything about any cheques that were banked by Mr Spence or his office?---Well, no I don't.

20

Did Mr Spence ever approach you for some support?---No.

Did any other Central Coast member of parliament or would be member of parliament approach you for support?---Mr Hartcher asked me for support for the Central Coast yes.

He did, but anyone else, Mr Webber?---No, I don't recall, no.

Did you ever raise any money for Mr Webber?---No, it was all done for the Central Coast.

Do you know the Mustaca family?---Yes, I do.

How do you know them?---Friends.

And good friends?---Yes.

How long have you known them for?---Long time.

40 And is Mr Anthony Mustaca a member of that family?---Yes.

Is he your main point of contact with that family?---Yes.

What does that, what does he do?---He's an investor.

Investor in what?---In real estate.

In real estate?---Yes.

Whereabouts?---In the Willoughby area I think.

In the Willoughby area?---Yes.

And have you received some donations from the Liberal Party from him? ---Yes.

How often would he provide a donation to you?---Um, probably, what in the, 2011 are you talking about?

Well start generally?---Generally, um, may be three or four times.

Ever or a year?---No, well, not a year, no, no.

Okay. Three or four times?---He's been to some of the dinners that I've had in the Manly conference that sort of stuff.

And generally, when he's provided you with a donation, what's the amount been?---Um, well, may \$900 to \$1,000 something like that.

And do you recall him giving you any donations in the lead up to the March 2011 election?---Yes.

Roughly, what amounts?---Um, around \$1,000, \$900 something like that yeah.

And just briefly, outline for us the circumstances in which those donations were given?---Well, he was at one of those dinners.

30

He attended the dinners?---Yes.

And what, he gave you a cheque for those dinners?---I think so yeah, I think he did, yeah, yeah.

And can you recall what you did with the Mustaca cheques?---No, I don't actually um, I could have sent it, I might have sent it to the Central Coast I really don't know because that money was for the Central Coast so I could have - - -

40

So again, when you say you might have sent it to the Central Coast that's a big region with a lot of residents and a few members or aspiring members, can you recall what - - -?---It would have been sent to Mr Hartcher's office.

Mr Hartcher's office?---Yes.

If I told you that it appears that those cheques ultimately made their way to Mr Spence's campaign, is that a surprise to you?---Um, no, I don't think so because those cheques were made for the Central Coast.

So was this the case that Mr Hartcher was saying to you in respect of the cheques that he received from you, I'll look after it, I'll make sure that they're allocated to the different members?---No, no, I don't think he said that, those - - -

What did he say?---That the, when he asked me to do those fundraisers they were for the Central Coast seats so it would have been Spence, whatever, two or three of them, three or four seats or whatever there are, it would have been for all those seats.

Did you ever follow up with him what was done with the money?---No I didn't.

You didn't spoke to him about how's going up there, how it's being deployed?---No.

20

Who got it?---No.

Do you recall there being a delay, we'll just quickly go back to the Trumbull cheques, there was a big delay in banking those cheques, do you remember?---Yes.

And I think Mr Trumbull might have made inquiries with you about why it had been so long, I gave you the cheques in March, it's now September and they haven't been banked?---That's right, yes.

30

What did you so in respect of those inquiries?---Um, I can't recall to be honest with you.

You presumably would have followed up?---Well, as I said to you before, when we get the cheques, they would go out fairly quickly within a few weeks.

But they hadn't been banked, we know they weren't banked for many months?---I don't know why, I've really got no idea why.

40

But you are on notice that they hadn't and presumably you followed up, you made some inquiries, did you call Mr Hartcher?---No, I didn't.

Who would have called?---I didn't call anybody.

You just sat on the inquiry?---Yes, I, I, I'm not sure whether - - -

Why wouldn't you, you've got a donor, who clearly you want to keep in the good books.---Yes.

He's made a donation and he's called you and he said, I made these cheques in March, they haven't been banked, would you mind, we need them to be banked - - -?---Look, I don't recall the conversation with Mr Trumbull.

MR PARISI: Can I just make an objection.

10 THE COMMISSIONER: Just a moment, yes.

MR PARISI: Mr Trumbull's evidence yesterday was not inquiring that he had knowledge that they had not been banked - - -

THE COMMISSIONER: No, no, his inquiry was to the issue - - -

MR PARISI: - - - when they were banked.

THE COMMISSIONER: Yes, as to the, as to when they were banked so that his employees could receive receipts for taxation purposes as I understand it.

MR PARISI: That's correct. The question is, that he was inquiring as to when they were being banked not inquiring as to why had they not been banked.

THE COMMISSIONER: Well, it might be a distinction without a difference but we'll go on.

30 MR PARISI: Thank you.

40

THE COMMISSIONER: Thank you.

MR O'MAHONEY: It's an inquiry, he said to you that these cheques were provided in March and they haven't yet been banked?---I don't recall him saying that to me but he could have said that to me.

I thought moments ago you accepted he did put through this follow up inquiry about why the cheques hadn't been banked?---I don't recall that he did.

But you did a minute ago, sir?---No, no, no, I don't think so.

So you don't recall any conversation with Mr Trumbull?---I don't recall the conversation, I've seen the I've seen the stuff, I've seen information that the staff have - - -

So when you said moments ago you just sat on the inquiry, you don't think you followed it up with anyone - - -?---Look, I just don't recall.

You were just speculating, you were pretending that the inquiry had been made.---I don't recall.

Can I ask one final question, have you ever raised funds from a Mr Nick Scali?---Yes, oh sorry, have I, have I, has he been at any of my functions?

Has he been a donor through you to the Liberal Party?---He's been to the – yes he has. He's been to a dinner or two dinners I think yes.

The dinners we've been talking about?---Yes.

And how much did he donate?---Look I can't remember, it would have been \$1,000 may be \$900, probably \$1,000 I think it was.

Do you know Mr Scali well?---Yes I do.

Is he a good friend?---Yes, he's a good friend.

Has he provided any other donations to you?---No.

To the Liberal Party through you?---No, only, only - - -

We'll call them the Scali cheques, do you know what happened to them?---Well I see, I presume these are the, these one's that you're talking about, they were the Scali cheques, they would have been from the dinner.

And so in other words, the Scali cheques, are you understand it, ended up on the Central Coast?---Yes, it looks that way yes.

And did you ever speak to, did you ever speak to Mr Hartcher about what was done with those cheques?---No.

You have no knowledge of those cheques being used in the context of Mr Spence's campaign?---No, oh, I know that they would have been used for the Central Coast campaign but that's about it.

40 No further questions Commissioner.

THE COMMISSIONER: Anyone have any questions of Mr Caputo? No, anything arising Mr Kerkyasharian?

MR KERKYASHARIAN: Briefly Commissioner.

Mr Caputo, you were shown – you were shown, can I have 3972 put up. You were shown page 3972, I don't know what document, this is the John

Caputo President of the Manly Conference Invitation, it was in the bundle that was handed to you?---Oh yes, I've got that here.

And you were asked in relation to that Mr Caputo whether there was anything on that that would suggest that these funds or this dinner had any relationship with the Central Coast – it's the case that Mr Hartcher at the time was a prominent member from the Central Coast?---Yes.

And if you have look at that document it says there, in fact, that he was the Shadow Minister for the Central Coast?---That's right.

It also says at the bottom of that document, please make cheques payable to the Liberal Party of Australia New South Wales Division, can you see that at the bottom?---Yes, that's right, yes.

To your recollection, is that in fact where the cheques were made out to? ---Yes.

What about the one's from Mr Trumbull were they made out to there as well?---Yes, they were.

And up until you found out otherwise in the course of this investigation and so on, did you think that cheques deposited – cheques that were written out to the Liberal Party did you think that they could be deposited anywhere other than an account run by the Liberal Party?---No, I did not, I was shocked that could happen.

Did you can you see that a solicitor had the ability to do this?---No, I didn't, I wasn't aware of that, I thought the cheques would have had to banked in a

And so is it the case then to your mind wherever you'd sent the cheques assuming they were kept in the Liberal Party - - -?--Yes.

--- they would not have been taken outside that, is that right?---That's right.

Thank you, Commissioner.

30

40 THE COMMISSIONER: No other questions for Mr Caputo?

MR O'MAHONEY: Nothing arising.

THE COMMISSIONER: Nothing arising. Thank you, Mr Caputo, you may step down, you're excused.

Have you ever heard of the business Eightbyfive?---I only know about that name when the ICAC approaches our office inquiring about the company called Eightbyfive around 22 April 2013 while I was in the State, yeah.

Well can I put it this way, to the best of your knowledge have you or any of your companies ever sought the services of Eightbyfive?---I have no recollection of that, sir.

Now do you know this chap Ray Carter?---Yes.

You have met him a few times?---Yes.

And has he solicited from you donations for the Liberal Party?---Um, not directly from me because he knows that I'm a properly developer I can recollect that but he might have asked for um, in the past of um, a function

to be organised where he wants or to introduce Chris to the community leaders and business leaders.

Introduce Chris meaning Chris Hartcher?---Chris Hartcher, yeah.

And community leaders and business leaders are people with whom you are familiar who you could introduce - - -?---That's right. And in particular that is the ethnic groups.

10 Could Mr Sunito be shown Exhibit S7, Commissioner. Would you open this up, Mr Sunito, at page 2011, 2-0-1-1. Do you see that invoice, it's from the business Eightbyfive and addressed to Crown Consortium?---Yes.

Do you see that? Do you know or are you able to explain how this came to pass that Eightbyfive would be issuing an invoice to Crown Consortium? ---Um, I do not have any recollection of that, sir.

And you'll see there that Eightbyfive is saying that they are offering market and commercial research. I don't want to get you boasting but your businesses are pretty big aren't they, Mr Sunito, that employ a lot of people?---Um, yes, sir.

And you do have very extensive marketing?---Yes.

And I mean, look I've seen the advertisements myself in the papers and things like that. You do have marketing organisations already - --?---Yes.

--- that you retain. Can you think of any reason why Crown Consortium would be retaining a marketing company based in Terrigal?---I don't have any recollection of that, sir.

If we look over the page at 2012 we've got the cheque butt for this payment, you'll see it there?---Yes.

Do you see that?---Yes, yeah.

Is that your handwriting?---No.

And if we even go further to page 2014 you'll see there that there's a, an image we've been able to capture from your books of your company - - -? ---Yes.

--- which refers to this Eightbyfive. Can you shed any light on this?---Um, it says that the creditor code is Eightbyfive and um, the address of the PO Box 3618 Erina and then um, um, what else um, Australia, um ---

Do you think that this may have been something that you were asked to do by Ray Carter to - - -?---I, ah hmm.

To, to pay this bill as it were this invoice?---I have no recollection of this, um, I was made aware of this Eightbyfive around at April 2013 and when I was made aware of that and I asked my staff to do searches about this company and that's when we discovered about this 2200 at the same time that my staff also produced the document or from Sydney Morning Herald that triggers an alarm for us um, because of allegedly of this um, the use of this company that might be actually possibly is giving it to a Liberal Party that we were, because we knew by 2009 we are not allowed, we are prohibited donors that are not allowed to give donation to the State parties at all so I've asked my staff and I, I could not, I don't have any recollection about this.

Well I'll just show you something else which is intriguing us?---Yes.

If you look at that page 2011 and if you look at the invoice issued by Eightbyfive you'll see at the foot of the page that the cheque is to be posted to a particular post office box address in Erina. Do you see that?---Yes.

And somebody's crossed it out and put in a replacement box. We've traced that box. Would you turn to page 2019. You'll see that Eightbyfive's invoice was actually asking that the account be sent to a PO Box which was held in the name of Chris Hartcher MP. Can you shed any light on that?---I, I – in what way, sir?

We'd like to know why Mr Hartcher was receiving cheques for Eightbyfive but do you know?---I don't.

All right. Well you mentioned something before about your staff having a look for things. Could you turn to page 2016. We, we did ask your staff to look for us to see whether they could ascertain any work or services provided by Eightbyfive. You're aware of that?---Yes, sir.

And you'll see at page - - -?---I have given that instruction to my staff, yeah.

Yes. And you'll see in paragraph 3 that the response given on behalf of the Crown Group of companies was that after having conducted an extensive search they were unable to locate any documents evidencing work performed by Eightbyfive or Tim Koelma. Do you stand by that?---Yes, sir.

Now you did mention also earlier in your evidence something about Ray Carter, and functions and the like. Could you open up this same volume at page 1995?---1000?

1995, 1995. I'm just going to show you some- - -?---Yes.

- - - contact between you, Ray Carter and Chris Hartcher?---Yes.

You do know Chris Hartcher as well as Ray Carter?---Yes, I do, yeah.

Well, if we have a look at page 2000 we can see a further communication.

At page 2000- --?---Yes.

- - - the bottom of the page has got an email from you to Mr Carter in which you refer to your father being ill?---Yes, my dad was um, going to have to have a bypass in that month.

And Mr Carter responded commiserating with your father's ill-health and then he said this in the first paragraph, "Due to the changes in electoral funding I am unable to do a function in the way I spoke to you about after 31 December." Do you see that?---Yes, sir.

Now, he goes on to say that people would be supportive of a change of Government and then he goes on to say this, and these are the words we're intrigued by. It's something that was on an advertisement years ago, "The drink you're having when you're not having a drink." You haven't heard about that?

All right. Well, I think it's the case that there was some contact between Benjamin Chow and Mr Hartcher's office. We've seen that if you look at page 2004. Do you see that?---Yes, sir.

And then if I take you forward, you look at page 2006 through to 2012, you can flick through pages which show telephone contact and, and email contact between you and Mr Hartcher's office?---Is that page 2006 to- --

2006 and then if you turn over and- --?--Yes.

- - -look at the next page there's an email?---Yes.

And then at 2008 there's telephone contact and at 2009- -- ?--- Yeah.

Yes, that's not coming from you but it's very clear that the meeting request is one between Mr Hartcher and you, Mr Sunito?---Yeah, is that 2031?

Yes?---Yes.

That's a - you'll see your name there, a meeting request and what it is is that the fellow who's then working for Mr Hartcher is his advisor Tim Koelma.

MR NEAL: I object, the witness said he was looking at 2031.

MR WATSON: 2031?---Yes.

THE COMMISSIONER: Yes?---Yes, with Tim Koelma, yeah.

And your name is there and it's a meeting request. What was that about? What could Mr - - -

Apologise to Mr Gunasinghe. So Mr Stevens, if you look at that page 1,528 you'll see your signature on a \$10,000 cheque.---Yes.

And Tim Gunasinghe is the other signatory, is that right?---That's right.

And it's drawn on the account of Printban Pty Limited?---Yes.

And it's drawn in favour of Free Enterprise Foundation?---That's correct.

What we're trying to get to in this inquiry Mr Stevens is to find out is how that came to be, how it came to pass that this donation was to the Free Enterprise Foundation?---How the donation made, um, Printban day to day is handled the Brand Group and as far as the donation to Free Enterprise it was a, a it was a donation that was put forward to me - - -

By whom?---By Tim Gunasinghe as a manager of our group that he thought that there project or the donation had merit and on that basis we supported it.

40 So the only contact with it you had, you say, is Tim Gunasinghe?---Tim is, I'd never heard of Free Enterprise and had to look it up, Free Enterprise Foundation recently when I was questioned about it.

Well, what does it, when Mr Gunasinghe came to you, what did you understand, did you understand that this was a payment for services or some sort of fee?---No, I didn't think it was.

You thought it was a donation?---That's right.

You can always give your money to the Blind Dogs or the Salvo, what did the Free Enterprise Foundation do?---I donate to a lot of groups - - -

It \$10,000 that's not chicken feed?---No it's not.

And you said that Tim Gunasinghe sold it a way that it was a suitable donation to make, was it because it provides meals for starving children?--Not to my knowledge, I thought it was for a group that were going to, a group that was going to raise business issues that were going to lead – I really wasn't aware what it was, what it was for as far as a day to day activity or what they were going to do.

Well, Mr Gunasinghe must have told you something which would have persuaded you that it was a good idea to put your signature on a \$10,000 cheque?---I believe that Tim was approached by other business people that 20 he thought that the idea of supporting issues that were within our community - - -

Well, he must have told you who those other people were?---I thought they were Central Coast business people.

No, don't think things, surely if you're about to sign a \$10,000 cheque you must have asked one or two questions such as, well who was it who brought this up? Now all I want to get from you is how did that come about?---Ah, it came about because some time in the middle of 2010 someone told me about them, I talked to a few people about the organisation.

Well, who spoke to you about it?---I don't remember.

Oh, Mr Hesky, really, I mean you can't remember who spoke to you about the Free Enterprise Foundation?---No.

Well, who did you then speak to about it?---I checked it out, I spoke to I don't know who and ah, I think I Googled it as well.

Yeah, well, that's great so you said you heard about it from somebody you can't remember - - -?---Yeah.

- - and then you spoke about it with somebody you can't remember, that's helpful evidence - -?---I asked, I asked - -

Well okay, you don't seem to be able to answer that. Can you answer this did you go to a school?---Yes.

Tell me were there any people in your class at school who became politicians?---Yes.

Oh really. Who was that?---Nick Greiner, Chris Hartcher.

Right. Do you think you might have spoken to Chris Hartcher about the Free Enterprise Foundation?---No.

No. How can you be so sure of that? You before couldn't recall even down to the vague occupational details of the person to whom you spoke. Why are you so certain it couldn't be Hartcher?---Well because I heard about them in the middle of 2010 and in 30 or 40 years I've spoken to Chris maybe four or five times and had lunch with him two or three included.

Have a look at page 1308?---Yeah.

What, people who, who, you mean in the political party sense?---Yes.

Not the vegetables?---No.

The – so where did you get that from? Did they have a website?---Well I think I looked it up in the, on, on the computer, I don't know.

Did you, did they have a website?---I didn't Google the website.

What did you Google?---Just the – when I heard about them I wanted to make sure that they were legit and - - -

THE COMMISSIONER: Yes. But what, what, what words did you insert in the search function?

MR WATSON: Tapped in something?---Yeah,. The, what is it?

40 THE COMMISSIONER: Free Enterprise Foundation?---The Free Enterprise Foundation.

MR WATSON: And what did you find, where did you get this information?---Who told me about it?

No, no, no, no. When you Googled it because you can be rest assured, Mr Hesky, other people have Googled it - - -?---Yeah.

--- and you don't get the information that you just listed?---Yes, you do.

All you'll get - - -?---You get - - -

You'll get is complaints made by New South Wales politician on the Labor side that the Free Enterprise Foundation is a front for the Liberal Party?---I saw that more recently and they, I saw at the bottom that the Liberal Party denied it in that article but - - -

THE COMMISSIONER: Well, sorry, Mr, I'm sorry. Can I just ask you though, Mr Hesky, when you undertook this Google exercise you said that was in mid 2010 did you?---Yeah.

And, and so something in the nature of - - -?---I think it, I think what came up was things like their returns or something corporate affairs or something like that.

What do you mean their returns? You mean the Federal, the Free Enterprise Foundation?---The Free Enterprise Foundation, yeah.

Well but, but normally when you type in a term like Free Enterprise Foundation - - -?---Yeah.

- - under a search function - -?---Yeah.
- - you'll get a series of entries down the page won't you?---Yes, yes.

Which correspond with the words you've inserted - - -?---Yes.

- 30 --- and you click on those ---?---Yeah.
 - - and it opens up various websites?---Yes.

Did the information that you received come from a website that looked like a Free Enterprise Foundation website?---I believe so.

Did it have a banner a Free Enterprise Foundation?---No, no, no, no, it was stories about them or - - -

40 Stories about them?---Yeah.

What, media stories or advertising material or promotional material?---I don't remember.

And so this material, this vague material you thought oh well no doubt I'll just bung out a cheque for \$9,900 to them?---Um, it wasn't quite like that.

Wasn't it?---Yes.

Well what is it? Did you or did you not want your money to end up in the pockets of the Liberal Party?---I did not know they'd end up in the pockets of the Liberal Party.

It's not an answer to my question, this is my fourth go at it. Did you or did you not want your money to end up in the pockets of the Liberal Party?---(No audible reply)

And did it come to the address at 9 Dickson Street Artarmon?---There's a typo, it's 7 Dickson.

All right. So it did come to your address Dickson Street Artarmon?---Yes, yes.

And did it come to that address shortly after you had written and sent the cheque away?---Yes.

And who was the receipt from?

MR WATSON: Commissioner, it's at page 1,311 if you wish to look at it.

THE WITNESS: From the Free Enterprise Foundation.

THE COMMISSIONER: All right. Can I just ask you one other thing though because this is important, the address, whether it be 7 or 9 Dickson Street Artarmon, is that a business address or a private address?---Business.

It's a business address?---Yes.

Thank you.

MR WATSON: Ever met Tim Koelma?---No.

Ray Carter?---Yes.

How do you know Ray Carter?---Through the Liberal Party I donated when Chris Hartcher first ran, I donated some money to the Liberal Party or to his campaign and then from that time on or 07 he would get Ray Carter to come and see me.

So how many times have you met with Ray Carter, just a guess, or best guess?---Two to three.

And so when Ray Carter would come to see you, what was it for?---He'd ring up first and ask if he could get a donation this year and we'd make a time.

And so when you say he would ring - - -?---Yes.

- - - it would be Carter who rang or would it be Hartcher who rang you?--- Carter.

And so, and he would come to see you where, in Sydney?---In my office in Sydney.

And did you give money?---In 07 I gave them money.

What happened in the build up to the 2011 Election, are you saying that Mr Carter forgot to call you?---No, he rang me middle/late 10 and I told him that I wasn't too happy about donating this year and or that year 2010 the Liberals, State Liberals and he said something like, he'd come and see me.

He'd come and see you?---Yes.

Did he do that?---Yes, a couple of months later I think in December.

December 2010.---Yes.

And what did he say to you?---He said that I should reconsider and give them some money, and I didn't change my mind.

Do you see a coincidence between the fact that this cheque of yours is in the hands of the Liberal Party in December 2010 and a visit from Mr Carter coinciding with that time?---Um - - -

Do you think the events are related?---I don't remember.

That's not what I'm asking, I mean, just thinking about it now, Mr Carter comes to see you in December 2010 to ask you for money for the Liberal Party correct?---Yes.

Now did, are you saying that's just a coincidence that at the same time that Mr Carter is seeing you and asking you for a donation for the Liberal Party that the Liberal Party gets a donation from you?---I don't know how this happened.

Well, doesn't it, if you think about it now and there's limits, I appreciate to your memory, but doesn't it suggest to you that it was Mr Carter who asked you to make out the cheque to the Free Enterprise Foundation?---I don't remember.

You don't remember?---No.

What does that mean, it could have been Mr Carter and the fact has now slipped your mind?---I don't remember.

I don't think you can dismiss that question as easily as that, could it be that Mr Carter did ask you to make the donation to the Free Enterprise Foundation but between December 2010 and today that fact has slipped your mind?---I don't remember.

That's not an answer to the question. Are you saying you don't remember my question, I'm not asking you about your memory, I'm asking you about whether Mr Carter could have asked you to make the donation to the Free Enterprise Foundation and you did it, could that have happened?---I don't remember.

Sorry?---I don't remember.

I'm not asking you whether you remember, could it be the case that Mr Carter when he came to see you in December 2010 was the person that - - -?--Could it be the case?

Yes.---It could have.

Thinking about it now it's very likely to be the case given the timing, Mr 40 Carter sees you in December 2010, you write out a cheque in 2010?---Well, the only thing wrong with that is that I had some time to look up and know who they are, he did not come to me and say write this cheque out to these people because I knew about them for a month or two before.

All right. Well, we've got evidence, you see, of Mr Carter forwarding cheques from time to time from a variety of people forwarding them onto the Free Enterprise Foundation – I withdraw that. We've got evidence, you see, of Mr Carter collecting cheques from donors, people like you, then

So you did, you didn't do the Google search or you did do the Google search?---I presume I did.

Anyway, you said that you wrote the cheque and you sent it off to them?---Yes.

Well, does that mean you put the cheque in the envelope and you got an address somewhere for the Free Enterprise Foundation and you mailed it?--- That's what I thought had happened until I saw this letter.
