REASONS FOR DECISION

Your access application

On 1 September 2014, the Environment Protection Authority (EPA) received your application and the \$30 application fee. You sought access to the following information:

The final report of Ferrier Hodgson's lead abatement strategy cared out for land at and around Boolaroo; related to lead from the former Pasminco Smelter.

Relevant information

A search of EPA's records has been undertaken to identify all government information falling within the scope of your application. The search involved Contaminated Sites Section of Hazardous Incidents and Environment Health Branch.

One email has been received from Contaminated Sites Section. This record has been identified as relevant to your access application.

Decision

I have today decided to release to you, in full, the information relevant to the scope of your application. Please find attached the released record.

Consultation

The government information to which you seek access includes information that is of a kind requiring consultation under section 54 of the GIPA Act, as follows:

Concerns another person's business, commercial, professional or financial interests

I consulted with the affected third parties to ascertain whether they have any objection to disclosure of some or all of the information and the reasons for such objection. On 11 September 2014, the third parties responded, stating that they have no objection to any of the records being released.

I have applied the public interest test and have determined that there is **no** overriding public interest against disclosure of the information. I have today decided that all information, including the pages that contain the business information of third parties, be released to you in full.

Form of access

You will be provided with access to the information I have decided will be released to you by way of email.

This decision is reviewable under section 80(i) of the GIPA Act. See below for further details about your review rights.

Processing charges

The \$30 application fee counts as a payment towards any applicable processing charges. There are no additional processing charges.

This decision is reviewable under section 80(j) of the GIPA Act. See below for further details about your review rights.

Disclosure log

My original decision included a decision that the information released to you may be of interest to other members of the public. Similarly, I have also decided that this additional information released under my further decision may be of interest to other members of the public.

Accordingly a description of the information will be included on the 'disclosure log', on a date no earlier than ten days after this notice is provided to you. The log will also indicate any information being made available to the public and how this information can be accessed. This decision is reviewable under section 80(m) of the GIPA Act.

Review Rights

If you do not agree with the decisions that I have made, you may seek review under Part 5 of the GIPA Act. Before you do so, I would encourage you to speak with me if you have any questions about this notice or require further information on your rights of review.

You have three avenues of review: internal review by a senior officer of the Environment Protection Authority, external review by the Information Commissioner or external review by the Administrative and Equal Opportunity Division of the NSW Civil and Administrative Tribunal (NCAT). Please see the enclosed information sheet for more details about your review rights.

You should note that the time for seeking an internal review is 20 working days, or 40 working days for external review, after the date of this notice of decision. That means you have until **14 October 2014** to lodge an internal review, or until **11 November 2014** to lodge an application for an external review.
