## SUBSCRIPTION TERMS AND CONDITIONS

By subscribing to the Newcastle Herald, you accept the following terms and conditions. For the avoidance of doubt, these Subscription Terms and Conditions relate only to Newcastle Herald subscriptions pre-purchased through Fairfax. It is up to you to determine whether or not a subscription to the Newcastle Herald will best meet your individual circumstances. Closed weekends and Public Holidays.

### 1) DELIVERY AREA

- a) **PRINT SUBSCRIPTIONS:**
  - i) Print Subscriptions are valid in NSW, where normal Newcastle Herald home delivery exists.
  - ii) Delivery of Print Subscriptions to addresses within security apartments or office buildings is subject to delivery capability.
  - iii) A Print Subscription may be discontinued by Fairfax with notice to the Customer where distribution services cease to be available. You may be entitled to a pro-rata refund or credit towards a digital subscription.
- b) **DIGITAL SUBSCRIPTIONS:**
  - i) Digital Subscriptions are valid from anywhere within Australia and overseas.
  - ii) Your login to access the Digital editions is restricted use on three (3) separate devices only
  - iii) Minimum operating system and software requirements (including access to the internet) are essential to obtain Digital Subscriptions. It is up to the Subscriber to maintain necessary software and hardware. Requirements for the iPad edition (including iOS software versions) are available at the iTunes App Store when you download the Newcastle Herald digital edition App. Requirements for the Android edition are available from the Google Play store when you download the Newcastle Herald digital edition. The desktop edition of the digital edition requires you to have a computer with reliable internet access, and either Microsoft Internet Explorer 7, Firefox 3 for Windows or Macintosh, Safari 3.1 for Macintosh Release Notes19. You will also need Adobe Flash Player version 9 installed, available from [www.adobe.com](http://www.adobe.com).
  - iv) The Digital Subscription is available for you to access for the entire subscription term.
- c) **PRINT+DIGITAL PACKAGE SUBSCRIPTIONS** are available only to Subscribers who meet criteria for both 1(a) and 1(b) above.

### 2) PROCESSING AND PAYMENT

- a) Prices quoted for Subscriptions are in Australian Dollars and are GST-inclusive unless indicated otherwise.
- b) Subscriptions will not commence until payment has been received.
- c) Fairfax will process your Subscription promptly. Your payment details must be verified before your Subscription can be activated. This may take up to 5 days to process.
  - i) If your initial payment authorisation is revoked, your Subscription will be terminated. We reserve the right to reject any subscription order or purchase at any time.
- d) **Direct Debit Subscriptions:**
  - i) Deductions will be made every 4 weeks in advance.
  - ii) Direct Debits require a valid credit card or bank account.
  - iii) You acknowledge that the Subscription price may be changed by Fairfax from time to time, by giving you at least 14 days' written notice. Any price changes will not take effect until the next billing date after the notice period. If you do not wish to continue your Direct Debit Subscription at the revised price, you may cancel your Subscription by contacting Newcastle Herald Subscriptions team at least five working days before the end of your current Direct Debit Pay cycle.
  - iv) The authority to debit your account every 4 weeks remains valid until you notify Fairfax that you wish to cancel your Direct Debit Subscription by contacting Newcastle Herald Subscriptions Department.
  - v) It is your responsibility to notify us if your Direct Debit account is cancelled closed or if your account details change before your next billing date.
  - vi) If we are unable to debit your account for any reason, we will notify you. Your subscription will continue during the notice period and payment details must be renewed within 12 business days. You will generally be required to clear any unpaid subscription fees, and reimburse us for any transaction fees that we incur as a result of a failed direct debit transaction, during the notice period, as a condition of continuing your subscription. Failure to do so will result in your subscription being cancelled.
- e) **Upfront Subscriptions:** the full, fixed term payment is due upfront.
  - i) Payment can be payable by cheque, money order, or credit card.
  - ii) At the end of the Subscription term, Fairfax may contact you in order to renew your subscription. Alternatively, you may contact Newcastle Herald Circulation in order to renew your Subscription at any time.
  - iii) Fairfax reserves the right to change the price of the Upfront Subscription and the duration of Upfront Subscriptions offered from time to time. For the avoidance of doubt, the price of your Upfront Subscription cannot be changed by Fairfax during the applicable term.
  - iv) If you choose to renew your subscription via BPay, please ensure the full payment is paid upfront. You should allow 5 working days for BPay payments to be processed.
- f) **Digital Subscriptions third party charges -**
  - i) The iPad app from iTunes store is free. The Android app from the Google Play store is free. Your subscription payments are for access to edition content.
  - ii) When you use your digital subscription, you may incur other charges, such as telecommunication fees, data fees or service provider fees. You are responsible for paying any additional charges.
- g) Customers are advised to never send cash through the mail.

### 3) MANAGING SUBSCRIPTIONS

- a) **TYPES OF SUBSCRIPTION**
  - i) A Subscription to the Newcastle Herald provides the subscriber with access to the Newcastle Herald throughout the subscription period only, either in Print or on a digital replica format. Unless renewed with a payment, it will not be extended past the end of the subscription period.
  - ii) A **Print Subscription** entitles the subscriber access to receive the printed edition of the newspaper on their selected subscription days throughout the predetermined subscription period only.
  - iii) A **Digital Subscription** - Provides the subscriber with access to the digital replica edition of the newspaper (via an iPad, Android or Desktop computer) every publishing day throughout the predetermined subscription period only. Editions are available to access for up to two weeks after the publishing date.
  - iv) A **Print+Digital Subscription** - Provides the subscriber with access to the digital replica edition of the newspaper every publishing day throughout the predetermined subscription period. The Subscriber is also entitled to receive the printed edition of the newspaper on the selected days throughout the same subscription period only.
  - v) Any advertised discounts apply if you choose to access and receive all copies throughout the entire subscription term only.
- b) **COMMENCING SUBSCRIPTIONS**
  - i) Advanced prepayment is required for all subscriptions [see section (2) Processing and Payment].
  - ii) You will need to allow up to 3 business days notice to start a Print Subscription (or print component of a Print+Digital Subscription).
- c) **SUSPENDING SUBSCRIPTIONS**
  - i) Suspensions are based on providing access to the Newcastle Herald for a specific subscription period. The suspension terms apply whether your subscription is a Print only Subscription, Digital only Subscription, or a combined Print+Digital Subscription.
  - ii) Your Print delivery may be temporarily suspended by you.
    - (1) You will need to give Fairfax at least 2 business days' notice, and also tell us the date that you would like your Print delivery to restart.
    - (2) You will be permitted to suspend your print delivery for a maximum period of 90 days on each occasion. If you fail to provide a restart date, and fail to restart your print delivery within 90 days following its suspension, we may cancel or restart your subscription with notice to you.
    - (3) Delivery of the print component will not be made during any suspension period notified to Fairfax. Your subscription will be extended for the same amount of editions you did not receive during your suspension period.
  - iii) Your Digital Subscription may not be suspended under any circumstances. You will continue to have access to the digital edition throughout the subscription term. If you choose not to access your digital subscription edition the expiry date of your Subscription will not be extended and you will not be entitled to any refund in respect of the suspension period.
  - iv) For Direct Debit Subscriptions, payments will not be deducted (every 4 weeks) during the suspension period.
- d) **REDIRECTING SUBSCRIPTIONS**
  - i) If you move house, you may transfer your Print Subscription (or print component of a Digital+Print Subscription) to a new address provided it is within a Newcastle Herald service area.
  - ii) Your print subscription delivery address can be changed by giving Fairfax at least 2 business days notice.
  - iii) If your new address is in an area not serviced by the Newcastle Herald you may:
    - (1) Nominate an alternative delivery address within a serviceable area
    - (2) Transfer any remaining pro-rata credit to a Digital Subscription
    - (3) Cancel your subscription and apply for a refund [see 3(f) CANCELLATIONS]

- iv) A temporary re-direction of your Print Subscription to a temporary address is only permitted to a serviceable area for re-directions of 14 consecutive days or more.
- Digital Subscriptions**
- v) Digital Subscriptions can not be redirected to another user.
- e) **MODIFYING SUBSCRIPTIONS**
- Print Subscriptions and Digital Subscriptions:**
- i) Your Subscription delivery details can be changed by giving Fairfax at least 2 business days notice.
- ii) Subject to availability, you may change your subscription only once prior to the expiry of your current subscription term. (ie Print only to Print + Digital).
- iii) If you choose to change your subscription type, the balance of the amount paid in advance for your current subscription will be applied to the cost of your new subscription on a pro-rata basis.
- Digital Subscriptions only:**
- iv) Your Digital Edition username and password cannot be provided to someone else.
- v) If you experience technical problems accessing your Digital Edition Subscription, it is your responsibility to notify Newcastle Herald Subscriptions Department to receive assistance.
- vi) Fairfax reserves the right to modify the price, content, inclusions, type and availability of any digital product at any time. If your subscription package changes, we will give you 14 days notice in writing. If you do not wish to continue your subscription, you must notify us to cancel your subscription no later than five working days before your next billing cycle. If you do not notify us, Your package change will automatically take place from your next billing cycle.
- f) **CANCELLATIONS**
- i) You may cancel your print subscription at any time by contacting Newcastle Herald Subscriptions Department on 1300 726 437.
- ii) It may take up to 3 working days to process a cancellation of your print subscription.
- iii) **Upfront Subscriptions:** A cancellation fee may apply to Upfront Subscriptions cancelled prior to expiry of the applicable term. This is due to administration costs incurred in processing a cancellation.
- (1) A pro-rata refund will be provided, less any applicable cancellation fee imposed.
- (2) A cancellation fee of up to \$50 may apply to upfront subscriptions that are cancelled before the full subscription term has been completed.
- (3) No refund is given to Customers on a promotional rate.
- (4) No refund is provided on Subscriptions cancelled within 2 months of the expiry date.
- (5) No refund is provided if the amount to be refunded is less than \$10.00
- (6) Fairfax reserves the right to suspend or cancel your subscription at any time in its absolute discretion. In the event Fairfax cancels your subscription, you will receive a pro-rata refund for the balance of the term on your Upfront Subscription.
- iv) **Direct Debit Subscriptions:** If you do not wish to continue your direct debit subscription you may cancel your subscription by contacting Newcastle Herald Circulation at least 5 working days before the end of your current direct debit pay cycle.
- (1) No refund is given to Direct-Debit Subscriptions. The Subscription will simply expire at the end of the four week period for which payment has already been debited.
- v) If you have a Print Subscription packaged with the Digital Edition and you cancel that subscription, access to the Digital Edition component will cease on the same day that the Print Subscription component ceases to be delivered.
- vi) Fairfax reserves the right to suspend or cancel your subscription at any time in its absolute discretion. Fairfax will notify you of such suspension or cancellation. In the event Fairfax cancels your subscription, you will receive a pro-rata refund for the balance of the term on your subscription.
- vii) In the event of a cancellation of your Subscription by You or Fairfax as a result of ongoing major delivery problems or non-delivery within your area, no cancellation fee will apply.
- viii) If you are entitled to a refund, you may need to request it as it may not automatically be processed. Please allow up to six weeks for a refund to be issued.
- 4) **PROMOTIONS**
- a) From time to time Fairfax offers promotional items with its newspapers. Fairfax does not guarantee that newspapers delivered to Subscribers will include these items. From time to time, these items will be available for collection at a newsagency or Fairfax's offices. At its discretion Fairfax will communicate with its subscribers about the availability of such items.
- b) Fairfax may at times offer special promotional offers. The specific terms and conditions of each promotion will be clearly stated at the time of the promotion and will apply in addition to these Subscription Terms and Conditions.
- c) In the event of any inconsistency between the terms and conditions of a special offer and these Subscription Terms and Conditions, these Subscription Terms and Conditions will apply.
- d) Fairfax reserves the right to offer promotions with free digital access for a limited period of time. During this time existing subscribers will not be eligible for a refund.
- 5) **DIGITAL PRODUCTS:**
- a) When you purchase a Digital Subscription that includes the iPad or Android app, your purchase and terms of use will also be subject to the Apple Terms of Service, available at [www.apple.com/legal/terms](http://www.apple.com/legal/terms) and the Google Terms of Service, available at [https://play.google.com/intl/en-US\\_us/about/play-terms.html](https://play.google.com/intl/en-US_us/about/play-terms.html)
- b) If any or all of our digital products are temporarily unavailable, you will not automatically be entitled to receive a refund. We reserve the right to issue refunds or credits at our sole discretion. If we issue a refund or credit, we are under no obligation to issue the same or similar refund in the future.
- c) Login details associated with your Digital Subscription including username and password must not be shared. If any misuse is detected your subscription may be terminated and you will not be eligible for a refund.
- 6) **PRIVACY**
- a) You agree that your name, address, email address and telephone number will be collected and stored by Fairfax and used for the purposes of fulfilling Your Subscription, communicating with You about renewing Your Subscription and to notify You of any associated Customer offers or benefits or future subscriptions, unless otherwise notified by You.

- 7) **WARRANTY AND DISCLAIMERS**
- a) You agree that any errors made in entering the contact information and order details are Your responsibility and Fairfax is not liable for any consequences that may arise as a result of such errors or incorrect information, including but not limited to sending the Subscription to the address as notified by You. If you change your address or any other relevant details or do not receive your Subscription, You should notify Fairfax by calling Newcastle Herald Subscriptions Department.
- b) Fairfax is not liable to you for any loss or damage incurred by you arising out of your Subscription, whether direct, consequential, special, indirect or other loss or damage. In any event, Fairfax's maximum liability to you is limited to the value of the Subscription fees paid within the previous twelve months.
- 8) **GENERAL**
- a) These Terms and Conditions are for subscriptions to The Newcastle Herald, published by Newcastle Newspapers Pty Limited. Newcastle Herald Subscriptions may also be subject to Fairfax Media Subscription Terms and Conditions.
- b) You acknowledge and agree that you may use your Subscription for personal use only. You agree and acknowledge that Subscriptions cannot be exploited for any commercial purpose, including on-selling your Subscription to any third party. Despite this, Fairfax may, at its sole discretion, offer multiple copy subscriptions to certain organisations. Such corporate subscriptions can be arranged by contacting Newcastle Herald Circulation directly.
- c) You agree that all Subscriptions provided, benefits accepted or offers made by Fairfax shall be deemed to be provided in Australia, notwithstanding your location, and the terms of such shall be governed exclusively by the law of the State of New South Wales, and the Courts of New South Wales shall have exclusive jurisdiction to determine any such matters that may arise involving or alleged to involve Fairfax.

- 9) **DEFINITIONS**
- In these terms and conditions:
- a) "Fairfax", "we" or "us" means Fairfax Media Limited and its Related Bodies Corporate, including Newcastle Newspapers Pty Ltd, publisher of The Newcastle Herald.
- b) "Subscriber", "Customer" or "You" means a person who is a subscriber to The Newcastle Herald
- c) A "Subscription" means a standard fully paid Newcastle Herald subscription taken up directly with Fairfax, and for which these terms and conditions apply. A Subscription includes all parts and sections of the publication deemed part of the publication for home delivery; this may change from time to time in accordance with Fairfax's reasonable logistics and operational requirements.
- i) "Print Subscription", or "Print only Subscription" refers to the printed newspaper.
- ii) "Digital Subscription" refers to a digital replica of the printed version available on the iPad or desktop computer or similar device.
- iii) "Print+Digital Subscription" refers to a package deal of both the Print and Digital versions of the newspaper giving You access to both of these products for a specific time period.
- iv) **Subscription Term** refers to the time period that the product is available for the Subscriber to access. It does not extend due to voluntary temporary suspension.
- d) "DD or DDEB" refers to a subscription that is Direct Debited from your bank account or credit card.
